

1	STRIKING AMENDMENT TO PROPOSED ORDINANCE 2013-0344, VERSION
2	1
3	On page 1, beginning on line 4, strike everything through page 1, line 18, and insert:
4	"WHEREAS, fire district 28 is authorized to provide fire protection and
5	emergency services to an area of approximately sixty square miles that includes the city
6	of Enumclaw and the surrounding unincorporated area, and
7	WHEREAS, the commissioner serving in position 3 resigned from the board
8	effective June 10, 2013, and
9	WHEREAS, the commissioner serving in position 2 was seriously injured in an
10	accident and his wife, pursuant to a power of attorney, has submitted his resignation
11	effective July 17, 2013, and
12	WHEREAS, as a result of the two resignations, fire district 28 has two vacant
13	commissioner positions of the three commissioner positions authorized, and
14	WHEREAS, it is essential that there be at least two commissioners to conduct the
15	business of the board of commissioners of fire district 28, and

16	WHEREAS, RCW 42.12.070 gives the county legislative authority the duty to
17	appoint a commissioner for fire district 28 when there are two vacancies on the board,
18	and
19	WHEREAS, position 2 will be filled by election at the November 2013 general
20	election and it is appropriate to give the voters of the district the earliest ability to select a
21	new commissioner to take the place of the appointee, and
22	WHEREAS, Larry Jensen, who resides in council district nine and within the
23	service area of fire district 28, is willing to serve as a commissioner for the district;
24	NOW, THEREFORE, BE IT MOVED by the Council of King County:
25	A. Larry Jensen is hereby appointed as a commissioner in position number 2 for
26	fire district 28.
27	B. The term of this appointment shall last until a successor is elected and
28	qualified."

32	• Clarify which of the three commissioner positions of fire district 28 is being filled
33	by this appointment
