

1 **STRIKING AMENDMENT TO PROPOSED MOTION 2013-0342, VERSION 1**

2 On page 1, beginning on line 4, strike everything through page 3, line 25, and insert:

3 "WHEREAS, the council adopted the King County Metro Transit Strategic Plan
4 for Public Transportation 2011-2021 ("strategic plan") and the King County Metro

5 Service Guidelines ("service guidelines") in July 2011, and

6 WHEREAS, the strategic plan and service guidelines were updated in 2013 to
7 comply with Federal Transit Administration ("FTA") requirements, described in Circular
8 FTA C 4702. 1B, which require the transit division to establish certain system-wide
9 service standards and policies and evaluate service changes and fare adjustments to
10 determine whether those changes will have a discriminatory impact based on race, color
11 or national origin or will result in a disproportionate burden on low-income population;
12 and

13 WHEREAS, FTA regulations, in 49 C.F.R. Section 21.9(b), require all direct and
14 primary recipients of FTA funds to submit a Title VI program report every three years to
15 the FTA regional office, and updated regulations described in Circular FTA C 4702. 1B
16 require that "the Title VI program must be approved by the transit provider's board of

17 directors or appropriate governing entity or official(s) responsible for policy decisions
18 prior to submission to the FTA"; and

19 WHEREAS, the King County transit division, as a transit provider and direct
20 recipient of FTA funds, followed the appropriate federal regulations when developing the
21 2013 Title VI Program report and incorporated federal requirements into the strategic
22 plan and the service guidelines;

23 NOW, THEREFORE, BE IT MOVED by the Council of King County:

24 The council hereby approves the 2013 King County transit division Title VI Program
25 Report."

26 Delete Attachment A, 2013 King County Metro Title VI Program Report, and insert
27 Attachment A, 2013 King County Metro Title VI Program Report dated August 20, 2013

28 **EFFECT: Revises motion text to reflect Council action approving the 2013 Transit**
29 **Strategic Plan update, and makes minor typographical corrections. Replaces**
30 **transmitted Attachment A with a revised version that:**

- 31 • adds the revised 2013 Transit Strategic Plan update language, including the
32 revised King County Metro Service Guidelines language,
- 33 • updates and corrects references to Council legislative action and Committee
34 names,
- 35 • revises the list of civil rights complaints to include only Title VI complaints,
- 36 • updates the Language Assistance Plan section, appendix C, to include a
37 current multi-language brochure and noting plans for translation of the
38 Snow Guide and Title VI rights notification into additional languages,

- 39 • **adds a new appendix D listing subrecipients of federal transit funds and**
40 **relettering subsequent appendices.**
