SUMMARY

Proposed Motion 2013-0396 (Att. 1) would make an appointment to fill the vacancy in the position of state representative for the 41st Legislative District.

BACKGROUND

The 41st Legislative District includes all or parts of the communities of Bellevue, Factoria, Issaquah, Mercer Island, Newcastle, and Renton, among others. The boundaries of the district are shown in the attached map (Att. 2).

One of the state representatives for the 41st Legislative District, Representative Marcie Maxwell, resigned effective 15 July 2013 to become Senior Education Policy Advisor in the Legislative Affairs and Policy Office of Governor Jay Inslee (Att. 3). This has created a vacancy in one of the two positions of state representative for the 41st District.

As King County's legislative authority, the Council is responsible for making an appointment to fill the vacancy in the position of state representative for the 41st Legislative District. Washington Constitution, art. II, § 15 (Att. 4).

The appointee must be from "the same political party as the legislator or partisan county elective officer whose office has been vacated, and shall be one of three persons who shall be nominated by the county central committee of that party." Washington Constitution, art. II, § 15 (Att. 4).

The Council must make the appointment "within sixty days after the vacancy occurs." Washington Constitution, art. II, § 15 (Att. 4). Since this vacancy occurred on 15 July 2013, the Council must act no later than Friday, 13 September 2013.

The person appointed by the Council will serve until certification of the election of a successor in November of 2014. RCW 29A.24.171 (Att. 5)

THE NOMINEES

As provided in the state constitution, the King County Democratic Central Committee ("KCDCC") has nominated the following candidates to fill the current vacancy:

- 1. Ms. Tara Senn
- 2. Mr. David Ellis
- 3. Mr. George Pieper II

The nominees are listed in order of preference. As described in a 22 August 2013 letter from Karl de Jong, chair of King County Democrats (Att. 6):

The candidates are presented in ranked order as they were voted for and nominated by the 41st Legislative District Democratic Party organization and subsequently unanimously ratified by the King County Democratic Central Committee. You should consider the ranking as the preferred order in which the Democratic Party would expect the Council to consider these candidates.

Biographical information on the nominees, consisting of the questionnaire that each nominee completed as part of the nomination process, is included in these materials as Attachments 7 through 9.

Two recent news articles about the nomination process are also attached (Atts. 10 and 11).

<u>AMENDMENT</u>

In its current form, the proposed motion has a blank for the name of the person to be appointed. The blank will need to be filled in by amendment of the motion.



Washington State Constitution, Article II, Section 15

VACANCIES IN LEGISLATURE AND IN PARTISAN COUNTY ELECTIVE OFFICE. Such vacancies as may occur in either house of the legislature or in any partisan county elective office shall be filled by appointment by the county legislative authority of the county in which the vacancy occurs: Provided, That *the person appointed to fill the vacancy must* be from the same legislative district, county, or county commissioner or council district and the same political party as the legislator or partisan county elective officer whose office has been vacated, and shall be one of three persons who shall be nominated by the county central committee of that party, and in case a majority of the members of the county legislative authority do not agree upon the appointment within sixty days after the *vacancy occurs*, the governor shall within thirty days thereafter, and from the list of nominees provided for herein, appoint a person who shall be from the same legislative district, county, or county commissioner or council district and of the same political party as the legislator or partisan county elective officer whose office has been vacated, and the person so appointed shall hold office until his or her successor is elected at the next *general election, and has qualified*: Provided, That in case of a vacancy occurring after the general election in a year that the office appears on the ballot and before the start of the next term, the term of the successor who is of the same party as the incumbent may commence once he or she has qualified and shall continue through the term for which he or she was elected: Provided, That in case of a vacancy occurring in the office of joint senator, or joint representative, the vacancy shall be filled from a list of three nominees selected by the state central committee, by appointment by the joint action of the boards of county legislative authorities of the counties composing the joint senatorial or joint representative district, the person appointed to fill the vacancy must be from the same legislative district and of the same political party as the legislator whose office has been vacated, and in case a majority of the members of the county legislative authority do not agree upon the appointment within sixty days after the vacancy occurs, the governor shall within thirty days thereafter, and from the list of nominees provided for herein, appoint a person who shall be from the same legislative district and of the same political party as the legislator whose office has been vacated. [AMENDMENT 96, 2003 House Joint Resolution No. 4206, p 2819. Approved November 4, 2003.] [Emphasis added.]



RCW 29A.24.171

Vacancies in office.

- (1) If, prior to the first day of the regular filing period, a vacancy occurs in an office that is not scheduled to appear on the general election ballot, leaving an unexpired term for which a successor must be elected at the next general election, filings for that office shall be accepted during the regular filing period. The filing officer shall provide notice of the vacancy and filing period to newspapers, radio, and television in the county, and online. The position shall appear on the primary and general election ballots unless no primary is required or unless a candidate for superior court judge is entitled to a certificate of election pursuant to Article 4 [IV], section 29 of the state Constitution.
- (2) If, on the first day of the regular filing period or later, a vacancy occurs in an office that is not scheduled to appear on the general election ballot, leaving an unexpired term, the election of the successor shall occur at the next succeeding general election that the office is allowed by law to have an election. [Emphasis added.]

2013 Addendum

What revenue sources, if any, would you support to stabilize budgeting in your jurisdiction?

Our state needs additional revenue to meet the paramount duty of fully funding public education and maintaining critical services for our communities.

- I support an increase in the gas tax to help fund completion of the 520 bridge, public transit services and roads. In addition, I support local options for counties and cities to raise revenue for their own transportation-related needs.
- There are a variety of tax breaks that could be eliminated, eg for oil companies.
- Exploring a carbon tax to help lower green house gas emissions is also an option in which I am interested.
- I support taxes on gum, soda, candy, etc.

What actions will you take to improve access to social safety net programs – be they homeless shelters, affordable and workforce housing, and/or health care, among others – in your jurisdiction?

Supporting those in greatest needs in our community is a value I hold in high regard. I have served on the Mercer Island Youth and Family Services (MIYFS) Foundation board and the Jewish Federation of Greater Seattle board which support women, families, children and refugees in need locally and abroad.

While on the Mercer Island City Council, I voted to

- Expand utility assistance to help more people who are struggling to make their payments
- Approve a new development with 13 units of affordable housing in our Town Center
- Support funding for ARCH, and
- Fund MIYFS, which provides counseling, emergency assistance, food, childcare scholarships and other services for residents.

On a statewide basis, I will support:

- Promotion and full implementation of the Affordable Care Act to ensure all people have health insurance.
- Adequate funding of the State Food Assistance Program
- Services for refugees and immigrants
- Mental health parity
- Critical safety net for disabled adults

What do you believe needs to be done, if anything, to improve education and access to education in your jurisdiction?

First and foremost, the state legislature must meet its constitutional responsibility to fully fund K-12 public education. Part of these funds must cover full-day kindergarten and pay for basic education. We also must continue to focus on shrinking the opportunity gap, improving graduation rates, and incentivize teachers to earn their national certification.

Early learning is critical. To help all children enter school ready to learn, I support expanding the Early Childhood Education and Assistance Program.

Technical colleges and community colleges need our support and respect as they serve many in our community who work and study, are learning a trade and are preparing for a four-year degree.

Please identify, and explain how you plan to address, transit and transportation infrastructure needs in your jurisdiction.

Transportation funding is sorely needed in King County. I-520 bridge replacement funding is not secured. The I-405 to 167 interchange is a bottleneck, and many roads and bridges around King County and the state are in disrepair.

Our state legislature is long overdue in passing a transportation funding package that has local options for jurisdictions to work on key projects needed in their area and that supports roads and transit. I opposed tolling on I-90 and instead look to a regional transportation funding solution that addresses the various large projects being undertaken in our King County area.

To keep construction jobs, trade and businesses in our area we must have an improved transportation system that moves goods and people through less congested areas and faster.

What can your jurisdiction do to affect the environmental threats facing your jurisdiction, and what will you do to lead on such an effort?

During my tenure on the Mercer Island City Council, I have worked:

- To strengthen our Shoreline Master Program
- To meet a Citywide green power challenge and, as a result, install a new solar array at the Mercer Island Community Center
- On the first Sustainability Task Force and as a Sustainability Committee member
- To successfully earn the Washington Conservation Voters endorsement for my City Council race
- As the Council liaison to the Utility Board, helping connect sustainability education and practices with effective delivery of water, stormwater and sewer services
- To propose and hopefully in November 2013 pass a plastic bag ban.

As a member of the state legislature, I will:

- Promote clean and renewable energy
- Support the Growth Management Act to protect farmland and prevent urban sprawl
- Support capital projects to collect and clean stormwater
- Explore a carbon tax to help reduce greenhouse gas emissions
- Work to help reduce traffic congestion that creates pollution.

Full funding of Education

- Full Day Kindergarten: Our commitment to free K-12 education must include full day Kindergarten.

What revenue sources, if any, would you support to stabilize budgeting in your jurisdiction?

I would leave all options on the table. I am a strong believer in balanced budgets, and I refuse to introduce any new legislation which is not fully funded.

We need to cover costs for necessary improvements in transportation and education. Yet, if we wish to uphold Governor Inslee's campaign promise of no new taxes, our options become limited; that's why I pledge to closely revisit certain exemptions to our sales tax.

Finally, in the absence of a statewide transportation solution, the legislature should grant county governments the ability to independently raise revenues to continue funding important projects, such as Metro transit.

What actions will you take to improve access to social safety net programs – be they homeless shelters, affordable and workforce housing, and/or health care, among others – in your jurisdiction?

The biggest threats to our social safety net programs are budgetary constraints. We can't afford to allow human services to shrink. Human services give hope and opportunity to the impoverished and disabled, and enable others to rebuild their lives and stay healthy. Continued funding for human services isn't only the moral thing to do, it's also smart economic policy. It's cheaper to provide basic human services than to pay for incarceration and visits to the emergency room.

What do you believe needs to be done, if anything, to improve education and access to education in your jurisdiction?

Education is the great equalizer. I firmly believe that properly funding schools is the paramount duty of the Washington State Legislature. I come from a family of educators; my mother, father, and both my brothers are all teachers. I would never support legislation which would compromise the ability of our teachers to lead in the classroom, or for our children to learn.

I strongly support full education funding. This includes free K-12 education. Unfortunately, full day kindergarten education is not free in Washington. This is unacceptable. I am a well-known visible civil rights leader in the LGBT community, which is a very strong and activated constituency of my base. From my time on the King County Civil Rights Commission, I have

worked closely with underrepresented groups, people of color, and civil rights groups on the Eastside in our district. As a business owner who has been working directly with other business owners in our area over the last 13 years, I have built a substantial client list that I can call to gain support for my political effort. When it comes to an open election in our democratic leaning swing district, to win we must not only capture the votes of our base but we need to grab the majority of folks in the middle as well. I own the domains for peopleforpieper.com and georgepieper.com and my website will be up and ready to take campaign donations by August 21st, the day we vote for the slate of candidates to go to King County Council for appointment. I will work my campaign every day that I am allowed for the November 2014 election, starting the day I am appointed as our Representative by the vote our PCO's and the King County Council.

I graduated from Camp Wellstone Candidate Training last year. Democrats select candidates for 41st District

August 27, 2013

Mercer Island City Councilwoman Tana Senn emerged as the frontrunner among three possible replacements to fill the 41st District state representative seat vacated by Marcie Maxwell.

Maxwell, a Democrat, resigned her seat July 9 to take a job with the governor's office. To fill the seat, members of her party nominated three candidates to replace her and presented those nominations to the King County Council.

The 41st district stretches from the northern parts of Renton to the southern parts of Sammamish, encompassing Mercer Island and Newcastle, and parts of Issaquah and Bellevue.

After three rounds of voting Aug. 21, the 41st District Democrats nominated Senn, David Ellis, a former field director with Washington United for Marriage, and businessman and civil rights advocate George Pieper.

The three candidates will now sit for interviews with the County Council in early September, before the council appoints one of them to fill the vacancy.

Senn received the majority of the votes, and even received the support of fellow candidates Ellis and Pieper as the nominee to fill the vacancy, 41st District Democrats Chairwoman Karol Brown said.

If Senn wins the appointment, all three of the lawmakers from the 41st District — the others are Sen. Steve Litzow (R) and Rep. Judy Clibborn (D) — will be from Mercer Island.

Appointed to the Mercer Island City Council in 2012, Senn spent most of her career on nonprofit marketing and government relations.

If selected for the 41st District seat, Senn has plans to run for the position in 2014, according to responses from her candidate questionnaire.

She identified the need to fully fund public education, the creation of a transportation package that fully funds the 520 bridge without relying on Interstate 90 tolls and increasing public safety as the top three issues facing the district.

Ellis, a 2006 graduate of Mercer Island High School, owns a voiceover company.

In 2012, he worked as a field director for Washington United for Marriage, a group that supported the gay marriage referendum. He has also worked on campaigns with the Sierra Club, Environment Washington and the Washington Public Interest Research Group.

Ellis identified fully funding education, protecting the environment and gun safety as the district's most important issues.

Pieper lives in Bellevue, but his company, OutSmart Office Solutions, is based in Mercer Island.

He has served on the King County Civil Rights Commission and presided over the statewide Washington Stonewall Democrats and Lesbian, Gay, Bisexual and Transgender Caucus.

Transportation, education and growth management and economic development are the most important issues facing the jurisdiction, according to Pieper.

Democrats nominate 3 Mercer Islanders for Maxwell's seat

The resignation of state Rep. Marcie Maxwell, a Democrat, of the 41st District has set in motion a process that remains obscure to most casual observers of state government. The political party of the outgoing legislator gets to nominate candidates for the interim replacement. The appointee must be a resident in the same district. Three candidates will be 'nominated' for Maxwell's seat, by a vote of the precinct committee officers (PCO) of the 41st District Democrats at an Aug. 21 meeting.

The King County Council will then meet and subsequently choose one of the three as the appointee or, in the event of Council deadlock, the governor will do so.

After 10 individuals expressed interest in Maxwell's seat, five candidates completed questionnaires for the one-year term. The seat will then be up for election in the fall of 2014.

There are 200 precincts in the 41st District; more than half do not have PCOs. Candidates can lobby for fellow Democrats to become PCOs, in order to promote their candidacy.

David Ellis

David Ellis is a 2006 graduate of Mercer Island High School. He holds a degree from Kenyon College with a double major in political science and theater arts.

According to his responses on the 41st District's candidate questionnaire, Ellis has been active as an organizer and fundraiser in statewide campaigns such as Washington United for Marriage, regarding Initiative 74, and in the Sierra Club, WASHPIRG, and environmental causes. He was a delegate to the Washington State Democratic Convention in both 2006 and 2012.

Despite his relative youth, Ellis believes he represents a new, unique voice for the Legislature. He calls his approach "passionate progress."

"I am an idealistic person," he said. "I know how to organize and build coalitions."

Like Maxwell, he said, he will be a strong voice on education and many other issues of importance.

On his questionnaire, Ellis lists off issues that matter to him and the 41st Democrats. The first matter is education to be fully funded from pre-kindergarten on; affordable higher education, the environment and sustainability. He wants to help ensure that there will be meaningful gun control, and passage of the transportation funding legislation. He is opposed to tolling I-90, but said we need to find a way to pay for maintenance of the state's highways.

Ellis is the grandson of Jim Ellis, now 92, the activist and visionary who led campaigns to clean up Lake Washington in the 1950s; finance mass transit, parks, pools and other public facilities through 'Forward Thrust' bonds in the 1960s; to preserve farmlands in the 1970s; to build and later expand the Washington State Convention & Trade Center in the 1980s, and to establish the Mountains to Sound Greenway in the 1990s.

It is big shoes to fill, his grandson admitted. But his family's involvement in the community was a formative part of his upbringing.

"It is what I know," he said.

Ellis, who has a polished speaking voice, started his own company earlier this year, David Ellis Voiceovers, to provide voiceover services to commercial entities. But since the news of Maxwell's resignation, he has been using his voice to promote his candidacy for her seat.

Tana Senn

Mercer Island City Councilmember Tana Senn was one of the first people who Marcie Maxwell told that she was resigning her seat in the Legislature to take a position in Gov. Jay Inslee's government. Later, Inslee himself called Senn to urge her to put her name in for her replacement. The first thing she thought, she said, was that she could not tell her parents the news.

"I was sad," she remembered. "They are both gone now."

Next, she thought of her children; one in elementary school and the other just starting middle school.

"I thought, I cannot do this because of them," she said. Then, "I thought, wait — I have to do this because of my kids."

Senn, concerned about education funding, and safety issues for children, sees her young family as an asset to state government. She noted that there are just a handful of legislators with young children in Olympia.

Hearing about Maxwell's plans was a big surprise, she said. "Honestly, I love local government, but there are things you cannot do at the city level like passing a transportation budget or improving gun control.

"It would be exciting to work on larger issues," she said. She sees her possible appointment to the Legislature, "not as 'a leaving,' but as a different way to serve Islanders."

Senn, who has not been active in the 41st District Democrats, said she attended her first meeting last month after she heard about the appointment and was elected that evening, as a PCO. Attending the meeting with her were six other Islanders who were also voted in as PCOs.

Senn joined the Mercer Island City Council in January 2012 when she was appointed to fill the remaining term of former Island mayor, Jim Pearman. She is running unopposed for her City Council seat, up for reelection in November.

Announcing her candidacy to retain her City Council seat last March, she told Islanders, "I am working hard to fight tolling on I-90 at the local, state and federal levels. At the same time, I'm focused on the day-to-day issues that make our Island a wonderful place to live — parks and open spaces, safe roads and sidewalks, a vibrant Town Center and quality education."

Senn said that she expects to remain on the City Council even if she is appointed to the year-long position.

Senn has a background in communications and government relations. Senn earned a Master in Public Policy and Administration from Columbia University.

Senn's volunteer involvement includes campaigning for the fire station and rescue truck levy campaign, Youth and Family Services, and the PTA at Island Park Elementary. She was on the board of the Jewish Federation of Greater Seattle for six years.

George Pieper

Business owner and civil rights activist, George Pieper has been an active member of the 41st Democrats for 11 years. He acknowledges up front what the intent is of the replacement process for Maxwell's seat in Olympia.

"For the 41st, the goal is to keep the seat Democratic — now and later," he said.

Pieper himself has been active in the Democratic Party for more than 22 years, first in the 36th Legislative District and later the 41st. His application states that he has been involved

in and led many party activities, including presiding over the statewide Washington Stonewall Democrats and the LGBT Caucus. He has been a member of the 41st District Democrats for 11 years, served as an acting Precinct Committee Officer (PCO), and then as an elected PCO in his precinct since 2008.

Born in California, Pieper, 42, came to Seattle as a young man. He put himself through college in Seattle. He is now a 17-year resident of Bellevue.

"This is my chosen home," he said.

He has an Island address for his business, OutSmart Office Solutions.

Pieper describes himself as a community leader, civil rights advocate, and business pioneer. He is the former vice president of the Greater Seattle Business Association, where he served on the board for eight years. For the last five years, he has served as the 6th District Commissioner on the King County Civil Rights Commission, and as the chair for two years. In 2012, Pieper was honored at the GSBA Business & Humanitarian Awards Dinner as the recipient of the President's Award for Community Leadership.

He has put his name in the statehouse hat once before, for the appointment to fill Fred Jarrett's Senate seat when the Islander decided to join the King County Council staff in January 2010, after being elected a few months earlier. Randy Gordon was appointed instead. He was later defeated by Islander Steve Litzow in the November general election for the seat.

Pieper said he is well connected and knows how to raise money. He is a prolific fundraiser for a range of organizations from KCTS9 to groups within the (LGBT) community.

"I have been fundraising forever," he said.

For more than 20 years he worked as an advocate for the environment, social justice, economic and LGBT equality issues.

Along with tackling the issues of education and transportation, Pieper says if he were appointed, he hopes to be able to launch a campaign finance effort.

Other candidates

The two other candidates for the open King County Council position are from Sammamish. They include Don Gerund, a former Boeing scientist and a 14-year member of the City Council there. Also, Seattle attorney, Greg Hoover who practices immigration law, civil matters, arbitration and mediation, has put his name forward.

Don Gerend is well-known in Sammamish as one of the original Sammamish City Council members — he still serves on the council. Gerend said he came to the state of Washington in 1962 from the flat lands of Wisconsin and never looked back.

"I've seen the state from the top of Mt. Rainier to scuba diving in the San Juans," he said.
"When Sammamish incorporated I decided it was time to give back. This is an opportunity to take it to the next level."

Gerend has a Ph.D. in astronomy from the University of Washington. "As a former rocket scientist at Boeing, college teacher (physics, astronomy, environmental science and business calculus), commercial real estate syndicator and investment manager, and private phone company owner and operator, in addition to the years in city government, I feel well qualified to address the wide range of societal, scientific and number-crunching challenges facing the State Legislature," Gerend states in his candidate questionnaire.

He supports the right of public sector workers to bargain and strike with the exception of police and fire where binding interest arbitration should continue to be the final resolution to the bargaining process, he said.

Gerend does not support the two-thirds majority for tax increases at the legislative level. He is also unsupportive of school vouchers. With regard to charter schools, he would support them with proper state guidance, but he advocates options for learning such as Running Start, AP classes and STEM high schools. Gerend's priority for the 41st District is transportation, balancing the state budget without raiding city and county revenue sources and making higher education and work force training affordable and accessible.

Gerend is proud of the fact that in his 14 years on the Sammamish City Council, the city of 48,000 residents has an AAA bond rating, over \$60 million cash in the bank, no bonded indebtedness, great infrastructure and has three times been judged by CNN/Money Magazine as among the 15 best cities to live in under a population of 50,000. This year Forbes listed Sammamish as the "Friendliest City in the US" under a population of 150,000.

Greg Hoover is an attorney with his practice, Hoover Law Group, in Seattle and Portland. He has lived in Sammamish since 1999. He said he believes he can help people by serving as the legislator for the 41st District.

Hoover received his Juris Doctorate from the University of Detroit Mercy School of Law in 1996. Subsequently he received his Qualified Lawyer's Transfer Test from Oxford Brooks University in London in 2008.

He is licensed to practice law in both Washington and Oregon. His expertise includes immigration law, civil litigation and personal injury, criminal defense, arbitration and

mediation, and pro hac vice. Hoover does not support the two-thirds majority for tax increases at the legislative level. He also does not support area standards of wages and benefits. Hoover is not in favor of charter schools or school vouchers.

He said the top three issues facing the 41st District are education for all children, improving the economy by encouraging job growth, and tolling I-90. He wants to improve traffic congestion and expedite light rail to the Eastside.

"In, 2010 when I ran for state representative, I doorbelled over 10,000 homes. I would do this again. In 2010 I, along with my team, raised approximately \$40,000 and ran a properly budgeted race. I would be willing to do this again," Hoover said.

Results from the vote will be posted on Wednesday.
