SUMMARY

Proposed Motion 2013-0488 (Att. 1) would confirm the appointment of Adrienne Quinn as Director of the Department of Community and Human Services.

BACKGROUND

As described on its web page, the Department of Community and Human Services (DCHS) is "dedicated to helping our region's neediest residents achieve and maintain healthier and more independent lives and to strengthening our communities."

DCHS includes the following divisions:

- Community Services;
- Developmental Disabilities; and
- Mental Health, Chemical Abuse and Dependency Services.¹

DCHS focuses its efforts in the following areas:

- Prevention and early intervention;
- Treatment:
- Ending homelessness;
- Criminal justice services as alternatives to incarceration; and
- Job training and employment services.

The service provided by DCHS are described more fully in Attachment 10, which is taken from the DCHS website.

As director of DCHS, Ms. Quinn will be responsible for the DCHS operations, planning, and budgeting.

An organizational chart for DCHS is part of the confirmation packet and is included in these materials as Attachment 9.

¹ The Office of Public Defense (OPD) used to be a part of DCHS, but in June of 2013, by Ordinance 17588, OPD became the King County Department of Public Defense.

Dear Councilmember Gossett:

I am pleased to present the enclosed motion for the King County Council's approval confirming Adrienne E. Quinn as the Director of the King County Department of Community and Human Services.

Ms. Quinn comes to the County from the Medina Foundation in Seattle, where as Executive Director she led strategic initiatives to build nonprofit capacity and improve services for vulnerable populations. Ms. Quinn was instrumental in working with human service providers in homeless housing, domestic violence programs, food distribution systems, and youth development programs in 14 counties in western Washington, including King County.

Prior to the Medina Foundation, Ms. Quinn served as Vice President for public policy and government relations for Enterprise Community Partners in Washington, D.C. She researched, developed, and advocated for federal policy initiatives on issues related to affordable housing, community development, homelessness, and self-sufficiency, including housing policy, community development, the Community Reinvestment Act, the future of Government Sponsored Enterprises (Fannie Mae/Freddie Mac), foreclosure interventions, housing tax and finance, and the Administration's place-based initiatives such as Sustainable Communities and Choice Neighborhoods.

As Director of the City of Seattle's Office of Housing, Ms. Quinn managed a department of 43 staff with a \$45 million budget. She successfully managed the Office of Housing's \$40 million annual grant and loan programs making grants and loans ranging from \$5,000 to over \$6 million to local nonprofit organizations. She co-chaired and managed administration of the Gates Foundation's \$40 million Sound Families Initiative, which provided funding for housing and services for 1,500 families in a three county area. Ms. Quinn developed housing

policy initiatives for the Mayor and City Council and managed programs including: multi-family lending; first-time homebuyer program; tax abatement and incentive programs to encourage for-profit developers to develop affordable housing; weatherization programs; asset management for 10,000 unit affordable housing portfolio; and disposition of city owned properties.

Prior to her extensive public service experience, Ms. Quinn practiced law for nine years with several Seattle law firms.

Ms. Quinn graduated magna cum laude from the Seattle University School of Law in 1996. She holds a Master of Divinity degree from Harvard University, and a Bachelor of Arts degree in history from College of the Holy Cross in Massachusetts. She has received a number of awards in her career, including being named one of Washington's Top 50 Women Lawyers in 2006.

Ms. Quinn's demonstrated leadership and management skills and her extensive public service experience make her excellent choice for leading the Department of Community and Human Services.

It is my great pleasure to request the confirmation of Ms. Adrienne E. Quinn as the Director of the King County Department of Community and Human Services.

Executive Constantine names Adrienne Quinn to lead King County Department of Community and Human Services

Jackie MacLean stepping down after leading the department for more than a decade

King County Executive Dow Constantine today appointed Adrienne Quinn as director of the King County Department of Community and Human Services (DCHS). Quinn succeeds Jackie MacLean, who is stepping down at the end of 2013 after leading the department for 11 years.

"Adrienne will build on the solid foundation set by Jackie MacLean to deliver a wide range of human services –supporting veterans, ending homelessness, preventing and treating drug dependency, and providing mental health services," said Executive Constantine. "Adrienne's experience in both the public and private sectors will be crucial as we strive to help everyone in King County achieve healthier and more independent lives."

Quinn comes to the County from the Medina Foundation in Seattle, where as executive director she led strategic initiatives to build nonprofit capacity and improve services for vulnerable populations. Quinn was instrumental in working with human service providers in homeless housing, domestic violence programs, food distribution systems, and youth development programs in 14 counties in western Washington, including King County. Quinn previously served as vice president for public policy and government relations for Enterprise Community Partners in Washington, D.C., and as director of the City of Seattle's Office of Housing.

"I am looking forward to working with Executive Constantine and his staff, the County Council, DCHS staff, and community partners to end homelessness and ensure that King County residents have the services necessary to succeed in their lives," said Quinn.

Quinn graduated magna cum laude from the Seattle University School of Law in 1996. She holds a Master of Divinity degree from Harvard University, and a bachelor of arts in history from College of the Holy Cross in Massachusetts. She has received a number of awards in her career, including being named one of Washington's Top 50 Women Lawyers in 2006.

Executive Constantine praised MacLean for her service to King County.

"I want to thank Jackie MacLean for her leadership of the Department of Community and Human Services, and her work of 20 years on behalf of the people of King County," he said. "The partnerships she created not only strengthened our systems of care, but opened doors to housing, treatment, living-wage jobs and long-term stability for tens of thousands of our most vulnerable residents. Her contributions to housing and human services will resonate throughout our community for many years to come."

"I am exceptionally proud of my staff, our community partners, and the shared goals we have achieved for the people of King County," said MacLean. "I have thoroughly enjoyed my work as the director of the Department of Community and Human Services, and the timing is right for me to move on to my next adventure. I thank Executive Constantine for his support and leadership, and I look forward to working with Adrienne to ensure a smooth transition."

Quinn's appointment is effective November 1, and is subject to confirmation by the Metropolitan King County Council.

Congratulations! This letter is to confirm my offer and your acceptance of the position of Director of the Department of Community and Human Services (DCHS), effective November 1, 2013. Your appointment is subject to future confirmation by the Metropolitan King County Council.

Your work location will be in the offices of the DCHS, located in the Chinook Building at 401 Fifth Avenue, Suite 500, Seattle, WA. You will report to Rhonda Berry, Assistant Deputy County Executive. Your annual salary will be \$166,073.65, which is Range 87, Step 10 on the 2013 King County Ten Step Annual/FLSA Exempt Squared Schedule. This position is scheduled to be paid every other Thursday.

Your position is career service exempt, which means you are an at-will employee and serve at the pleasure of the Executive. Your position is exempt from overtime under the Fair Labor Standards Act; FLSA-exempt employees are paid on a salary basis and are not eligible for overtime pay or compensatory time accrual. However, pursuant to Executive Policy, PER 8-1-2, you are eligible for Executive Leave. You will be granted ten (10) days of Executive Leave to use before December 31, 2013. The position's duties and responsibilities will be elaborated on inmore detail on the first day of employment.

On your first day of work, please report to Rhonda Berry. She will arrange for you to meet with human resource staff, if necessary, and you will be asked to complete forms necessary for your employment.

Please understand that the provisions of this letter do not constitute an expressed or implied employment contract, but are simply statements of information that are important for you to know. This position is not represented by a labor union.

Developmental Disabilities helps infants and toddlers (birth to age three) with developmental delays; provides training and other supports for individuals with developmental disabilities who are working or who want to begin a pathway to employment; and supports a range of other family services and supports. **Find out more**.

Education and Employment Resources offers education and job training for at-risk youth and low-income adults. Services include in-school and out of school supports, GED preparation, on-the-job training, pre-employment and job search training, dislocated worker retraining, counseling and referral. **Find out more**.

Housing and Community Development coordinates a number of programs that help to prevent or reduce homelessness and build or repair housing and community facilities for low and moderate-income households and neighborhoods, including special needs and supportive housing, shelter beds, homeless prevention programs, affordable housing, first-time homebuyers assistance, and other programs. **Find out more**.

Mental Health services include individual, family and group therapy; case management; crisis services; medication management; employment services; residential services; and other supports. Services are provided to people of all ages who are eligible for assistance. **Find out more.**

Mental Illness and Drug Dependency Action Plan (sales tax funds) will provide services to improve and stabilize the lives of people with mental illness and chemical dependency. Strategies are designed to divert individuals from jails and emergency services into appropriate community treatment. A component of the plan focuses on crisis outreach and prevention efforts aimed toward children and youth. **Find out more**.

Substance Abuse prevention and treatment services include assessments, outpatient and residential treatment, opiate substitution, detoxification and sobering, employment training, violence and substance abuse prevention assistance and mini-grants, and other supports. **Find out more**.

Veterans and Community Services helps veterans, military personnel, and their families; seniors; survivors of domestic violence and sexual assault; and youth who are involved in or at risk of involvement in the justice system. **Find out more**.

Veterans and Human Services Levy, approved by the voters in November 2005, created a dedicated, six-year fund source to support housing and human services to assist veterans, military personnel and their families and other individuals and families in need. A Service Improvement Plan was developed to identify the target populations and the new or enhanced programs and services to be funded with levy proceeds. **Find out more.**
