**SUBJECT**

An ordinance adopting a collective bargaining agreement between King County and the International Brotherhood of Teamsters, Local 117, covering 17 employees who serve as legislative analysts for the county council.

**SUMMARY**

Proposed Ordinance 2013-0371 (Att. 1 to this staff report) would approve a collective bargaining agreement (CBA) between King County and the International Brotherhood of Teamsters, Local 117. The CBA (Att. 1-A) covers 17 employees who serve as legislative analysts for the county council.

**1. Term of the CBA**

The CBA covers the one-year period from 1 July 2013 through 30 June 2014. (CBA Article 22, Att. 1-A, p. 25)<sup>1</sup>

**2. The Bargaining Unit**

The committee is familiar with the duties of the 17 legislative analysts who make up the bargaining unit. As described in the Executive’s transmittal letter (Att. 4), those duties include:

- “Conduct qualitative and quantitative analysis of policy issues”;
- “Assist with the development and implementation of Council-directed initiatives”; and
- “Participate in the Council’s annual budget adoption process by analyzing budgets and financial plans.”

The bargaining unit consists of the following classifications:

- Legislative Analyst – Senior;

- Principal Legislative Analyst; and
- Principal Legislative Analyst – Senior.

See CBA Section 8.1 (Att. 1-A, p. 14) and Addendum A (Att. 1-B).

**CHANGED CONTRACT PROVISIONS**

There are few changes from the previous CBA. The most notable are described below.

**1. COLAs**

Section 8.2 (Att. 1-A, pp. 14-15) and Addendum B to the CBA (Att. 1-C) provide for the following cost of living adjustments (COLAs), which had previously been agreed to by MOA in 20122 and are the same as those agreed to with the vast majority of the county’s represented employees for the years in question:

Year	COLA Formula	COLA <sup>2</sup>
2013	95% of CPI-W increase for Seattle-Tacoma-Bremerton, <sup>3</sup> with 0% floor and no ceiling	3.09%
2014	95% of CPI-W increase for Seattle-Tacoma-Bremerton, with 0% floor and no ceiling	1.67%

The fiscal impact of the COLAs is described in the Fiscal Note (Att. 5). The COLA for 2013 is already being paid, since it was required pursuant to the “zero COLA” MOA.

Addendum B (Att. 1-C) also provides that COLA negotiations will be reopened if, comparing the current year to the previous year, there is either (1) an increase in the King County unemployment rate of more than two percentage points or (2) a decline of more than seven percent in county retail sales. Each year by July 30th the county will assess whether either of these conditions has been met. This is the same as the reopener that the county has agreed to with the vast majority of the county’s represented employees.

**2. No changes in pay ranges**

The CBA includes no changes in the pay ranges for the bargaining unit, which are listed in Addendum A (Att. 1-B).

### **3. Team Leader Pilot Project**

Addendum D (Att. 1-E) is a previously-agreed MOA from 2012 creating a pilot project whereby the council chief of staff or his designee may appoint up to five Team Leaders from among the bargaining unit members, subject to their consent to serve in that capacity. The purposes of the project is “to improve the delivery of services to councilmembers, as well as to ensure accurate and timely work.” The specific duties of the Team Leaders include:

- a. Consultation with committee lead staff to ensure adequate staffing to meet the needs of the committee.
- b. Mentoring and coaching assigned staff, as needed.
- c. Assigning work (in consultation with lead staff) to committee analysts and support staff.
- d. Reviewing work against professional and technical standards.
- e. Meeting on an ongoing basis with staff on his/her team to ensure that the work program goals are being met, and providing quarterly reviews based upon employee goals.
- f. Ensuring that needed training is provided, depending on availability of resources.
- g. Preparing performance evaluations.

The MOA further provides, “Employees designated as Team Leaders will be compensated at a rate which is five percent (5%) greater than their regular rate for all time so assigned.”

Finally, the MOA also provides that, “[i]n consultation with the Union, the Chief of Staff or designee may review and revise the program as needed, excluding revision of the compensation rate.”

### **4. Performance evaluations**

Addendum E (Att. 1-F) is a previously-agreed MOA from 2012 adopting a process for performance evaluations of bargaining unit members. The process has been reviewed and approved by the council’s Employment and Administration Committee. The MOA included attachments that consisted of the evaluation forms and evaluation instructions, which have not been made a part of Addendum E, but are incorporated by reference.

### **5. Clarifications and codifications**

The proposed new CBA includes several clarifications and codifications of existing practices.<sup>4</sup>

### **FISCAL IMPACT**

The fiscal impact of the CBA, which is attributable entirely to COLAs, is described in the Fiscal Note (Att. 5); however, the total cost increase for 2014 was already provided for in the zero COLA agreement in which most county employees joined. The new CBA makes no change in that regard.

The Fiscal Note was originally prepared on the basis of the OEFA projection for 2014. Now that actual data have become available, OEFA has determined that the actual COLA for 2014 will be 1.67% instead of 2.00%; therefore, the actual fiscal impact for 2014 will be slightly lower than the amount indicated in the Fiscal Note.

### **CONSISTENCY WITH LABOR POLICIES**

The proposed CBA appears to be consistent with the County's labor policies.

1            Provided however, that nothing contained in this section shall require an employee to join said  
2 Union who can substantiate in accordance with case law bona fide religious tenets or teachings that  
3 prohibit the payment of dues or initiation fees to Union organizations. Such employee shall pay an  
4 amount of money equivalent to regular union dues and initiation fee; said amounts shall be paid to a  
5 non-religious charity mutually agreed upon by the employee affected and the Union to which such  
6 public employee would otherwise pay the dues and initiation fee. The public employee shall furnish  
7 proof to the Union each month that such payment has been made.

8            **Section 2.3 Dues Deduction:** Upon receipt of written authorization individually signed by a  
9 bargaining unit employee, the County shall have deducted from the pay of such employee the amount  
10 of dues and initiation fee or the appropriate fair share payment for temporary employees, as certified  
11 by the Union, and shall transmit the same to the Union.

12            The Union will indemnify, defend and hold the County harmless against any claims made and  
13 against any suit instituted against the County on account of any check-off of dues for the Union. The  
14 Union agrees to refund to the County any amounts paid to it in error on account of the check-off  
15 provision upon presentation of proper evidence thereof.

16            **Section 2.4** The County will require all new employees hired, transferred, or promoted into a  
17 position included in the bargaining unit to complete a form to inform the Union of their hire. One  
18 copy of the form will be retained by County payroll, one copy of the form will be given to the  
19 employee and the original will be sent to the Union. The County will notify the Union of any  
20 employee leaving the bargaining unit.

21            **Section 2.5** The County will transmit to the Union a current listing of all employees in the  
22 bargaining unit within thirty (30) days of the Union's request for such a list, not to exceed twice per  
23 calendar year. For all employees performing bargaining unit work, the list shall include the name of  
24 the employee, classification, department and salary.

25            **Section 2.6** Failure by an employee to satisfy the requirements of Section 2 shall constitute  
26 cause for dismissal; provided that King County has no duty to act until the Union makes a written  
27 request for discharge and verifies that the employee received written notification of the delinquency  
28 including the amount owing, the method of calculation, and notification that non-payment after a

1 period of no less than seven (7) days will result in discharge by the County. A copy of each written  
2 notification shall be mailed to the County concurrent with its mailing to the employee.

3 **ARTICLE 3: RIGHTS OF MANAGEMENT**

4 **Section 3.1** The Union recognizes the prerogatives of the County to operate and manage its  
5 affairs in all respects in accordance with its responsibilities and powers of authority, subject to the  
6 terms and conditions of this Agreement.

7 **Section 3.2** The County shall have the right to discipline and discharge employees, and the  
8 right to layoff employees for lack of work or funds as part of a reorganization, for the occurrence of  
9 conditions beyond the control of the County, or when such continuation of work would be wasteful  
10 and unproductive. The County shall further have the right to hire, appoint, promote, train, assign,  
11 appraise employee performance, contract work and direct the workforce; develop and modify  
12 classification specifications, allocate positions to those classifications, determine work schedules,  
13 schedule overtime work, and to establish the methods and processes by which work is performed, the  
14 right to establish reasonable rules; and the right to take whatever actions are necessary in emergencies  
15 in order to assure the proper functioning of the Council.

16 **Section 3.3 Discipline and Discharge:** The parties recognize the critical importance of  
17 obtaining the highest levels of performance from unit employees, and thus have mutually embraced a  
18 requirement of high performance. The Union and the employees also agree upon the County's need  
19 to ensure employees fully comply with all rules, policies and practices of the County. As such, while  
20 the suspension, demotion and discharge of employees is subject to just cause, these standards and  
21 expectations shall be the baseline for any such determination.

22 Should the dispute resolution procedure be invoked in order to resolve a dispute concerning  
23 the employer's application of the just cause standard, the County's judgment shall be upheld unless it  
24 is found to be arbitrary and capricious. Any action which is based upon the County's judgment  
25 concerning the performance of a unit employee, and which has been documented through a process of  
26 performance management pursuant to Article 21, is final and may not be challenged through the  
27 arbitration procedure.

28 **Section 3.4 Payroll System:** The right to define and implement a new payroll system,

1 including but not limited to a biweekly payroll system, is vested exclusively in King County.  
2 Implementation of such system may include a conversion of wages and leave benefits into hourly  
3 amounts and the parties recognize King County's exclusive right to make the changes necessary to  
4 implement such payroll system.

5 **Section 3.5 Work Assignments:** In order to avoid work jurisdiction disputes, and to ensure  
6 that work is performed in the most efficient and appropriate manner, the County retains the right to  
7 make all work assignments, including the determination of whether work will be assigned to  
8 bargaining unit members or other County employees, and to reassign work into or out of the  
9 bargaining unit. Provided, however, no bargaining unit employees will be laid-off due to a decision  
10 by the County to assign work historically performed by bargaining unit employees outside the  
11 bargaining unit, prior to exhausting the statutory obligation to bargain.

12 **ARTICLE 4: HOLIDAYS**

13 **Section 4.1** Employees covered by this Labor Agreement shall be eligible for holidays with  
14 pay as provided by King County Code 3.12.230, as amended.

15 A. Employees shall be granted the following holidays with pay:

New Year's Day	January 1st
Martin Luther King Jr.'s Birthday	Third Monday in January
President's Day	Third Monday in February
Memorial Day	Last Monday in May
Independence Day	July 4th
Labor Day	First Monday in September
Thanksgiving Day	Fourth Thursday in November
Day after Thanksgiving	
Christmas Day	December 25th
Day Before New Year's Day	
Two (2) Personal Holidays	

28 and any special or limited holidays as declared by the president or governor, and as approved by the

1 Metropolitan King County Council.

2       **Section 4.2** For holidays falling on a Saturday, the Friday before shall be a paid holiday. For  
3 holidays falling on a Sunday, the Monday following shall be a paid holiday.

4       **Section 4.3** Personal holidays shall be administered through the vacation plan. One personal  
5 holiday shall be added to the vacation leave bank in the pay-period that includes the first day of  
6 October and one personal holiday will be added in the pay-period that includes the first day of  
7 November of each year.

8       **Section 4.4** An employee must be in a pay status, either the employee's scheduled work day  
9 before, or employee's scheduled work day after a holiday in order to receive holiday pay. An  
10 employee leaving County employment the day prior to the holiday shall not receive holiday pay.

11 **ARTICLE 5: VACATIONS**

12       **Section 5.1** Employees covered by this Labor Agreement shall be eligible for vacations with  
13 pay as provided by King County Code 3.12.190, as amended.

14       A. Employees shall accrue vacation leave as described in the following table:

1           B. Employees eligible for leave shall accrue vacation leave from their date of hire in a  
2 leave eligible position.

3           C. Employees eligible for leave shall not be eligible to take or be paid for vacation  
4 leave until they have successfully completed their first six (6) months of County service in a leave  
5 eligible position, and if they leave County employment prior to successfully completing their first six  
6 (6) months of County service, shall forfeit and not be paid for accrued vacation leave.

7           D. Employees eligible for leave shall be paid for accrued vacation leave to their date  
8 of separation up to the maximum accrual amount if they have successfully completed their first six  
9 months of County service. Payment shall be the accrued vacation leave multiplied by the employee's  
10 regular base rate of pay in effect upon the date of leaving County employment less mandatory  
11 withholdings.

12           E. Employees eligible for leave shall not use or be paid for vacation leave until it has  
13 accrued and such use or payment is consistent with the provisions of this Article.

14           F. No employee eligible for leave shall work for compensation for the County in any  
15 capacity during the time that the employee is on vacation leave.

16           G. In cases of separation from County employment by death of an employee with  
17 accrued vacation leave and who has successfully completed his/her first six (6) months of County  
18 service in a leave eligible position, payment of unused vacation leave up to the maximum accrual  
19 amount shall be made to the employee's estate, or, in applicable cases, as provided for by state law,  
20 RCW Title 11.

21           H. If an employee resigns from a full-time regular or part-time regular position or is  
22 laid off and subsequently returns to County employment within two years from such resignation or  
23 layoff, as applicable, the employee's prior County service shall be counted in determining the  
24 vacation leave accrual rate under Section 5.1.A.

25           **Section 5.2 Vacation Use.** In addition to the aforementioned vacation benefits provided in  
26 King County Code 3.12.190, employees eligible for leave may accrue up to (480 hours) of vacation.  
27 The County will give notice on or about July 1 of each year to employees whose vacation accrual will  
28 exceed 480 hours by the end of the year. Employees who leave King County employment for any

1 reason will be paid for their unused vacation up to the maximum specified herein. Employees must  
2 use vacation leave in excess of the maximum accrual amount on or before the last day of the pay  
3 period that includes December 31 of each year; unless the employee has received approval in  
4 accordance with County or Council policies and procedures to carry over excess vacation accrual into  
5 the following year.

6 **ARTICLE 6: SICK LEAVE**

7 **Section 6.1** Employees covered by this Labor Agreement shall be eligible for sick leave  
8 benefits as provided by King County Code 3.12.220, as amended.

9 **Section 6.2** Employees shall accrue sick leave benefits at the rate of 0.04616 hours for each  
10 hour in regular pay status excluding overtime up to a maximum of eight (8) hours per month.  
11 Employees shall accrue sick leave from their date of hire in a leave eligible position. The employee is  
12 not entitled to sick leave if not previously earned.

13 **Section 6.3** During the first six (6) months of service in a leave eligible position, employees  
14 eligible to accrue vacation leave may, at the Supervisor's discretion, use any accrued days of vacation  
15 leave as an extension of sick leave. If an employee does not work a full six (6) months in a leave  
16 eligible position, any vacation leave used for sick leave must be reimbursed to the County upon  
17 termination.

18 **Section 6.4** There shall be no limit to the hours of sick leave benefits accrued by an eligible  
19 employee.

20 **Section 6.5** Separation from or termination of County employment except by reason of  
21 retirement or layoff due to lack of work, funds, efficiency reasons or separation for non disciplinary  
22 medical reasons, shall cancel all sick leave accrued to the employee as of the date of separation or  
23 termination. Should the employee resign, be separated for non-disciplinary medical reasons or be laid  
24 off and return to County employment within two years, accrued sick leave shall be restored; provided,  
25 that such restoration shall not apply where the former employment was in a term-limited position.

26 **Section 6.6** Employees eligible to accrue leave and who have successfully completed at least  
27 five years of County service and who retire as a result of length of service or who terminate by reason  
28 of death shall be paid, or their estates paid for as provided for by RCW Title 11, as applicable, an

1 amount equal to thirty-five percent (35%) of their unused, accumulated sick leave multiplied by the  
2 employee's rate of pay in effect upon the date of leaving County employment, less mandatory  
3 withholdings.

4 **Section 6.7** An employee must use all of his or her sick leave before taking unpaid leave for  
5 his or her own health reasons. If the injury is compensable under the County's workers compensation  
6 program, then the employee has the option to augment or not augment time loss payments with the  
7 use of accrued sick leave. For a leave for family reasons, the employee shall choose at the start of the  
8 leave whether the particular leave would be paid or unpaid; but when an employee chooses to take  
9 paid leave for family reasons, he or she may set aside a reserve of up to eighty (80) hours of accrued  
10 sick leave. An employee who has exhausted all of his or her sick leave may use accrued vacation  
11 leave before going on leave of absence without pay, if approved by his or her appointing authority.

12 **Section 6.8** Accrued sick leave shall be used for the following reasons:

13 **A.** The employee's bona fide illness; provided, that an employee who suffers an  
14 occupational illness may not simultaneously collect sick leave and worker's compensation payments  
15 in a total amount greater than the net regular pay of the employee;

16 **B.** The employee's incapacitating injury, provided that:

17 An employee injured on the job may not simultaneously collect sick leave and  
18 worker's compensation payments in a total amount greater than the net regular pay of the employee;  
19 though an employee who chooses not to augment his or her worker's compensation time loss pay  
20 through the use of sick leave shall be deemed on unpaid leave status;

21 **C.** An employee who chooses to augment worker's compensation payments with the  
22 use of accrued sick leave shall notify the worker's compensation office in writing at the beginning of  
23 the leave;

24 **D.** Exposure to contagious diseases and resulting quarantine.

25 **E.** A female employee's temporary disability caused by or contributed to by  
26 pregnancy and childbirth.

27 **F.** The employee's medical, ocular or dental appointments, provided that the  
28 employee's supervisor has approved the scheduling of sick leave for such appointments.

1           **G.** To care for the employee's child if the child has an illness or health condition  
2 which requires treatment or supervision from the employee;

3           **H.** An employee may not collect sick leave for physical incapacity due to any injury or  
4 occupational illness which is directly traceable to employment other than with the County.

5           **I.** To care for other family members, if:

6                   1. The employee has been employed by the County for twelve months or more  
7 and has worked a minimum of one thousand forty hours in the preceding twelve months;

8                   2. the family member is the employee's spouse or domestic partner, the  
9 employee's child, a child of the employee's spouse or domestic partner, the parent of the employee,  
10 employee's spouse or domestic partner or an individual who stands or stood in loco parentis to the  
11 employee, the employee's spouse or domestic partner; and

12                   3. the reason for the leave is one of the following:

13                           a. the birth of a son or daughter and care of the newborn child, or  
14 placement with the employee of a son or daughter for adoption or foster care, if the leave is taken  
15 within twelve months of the birth, adoption or placement;

16                           b. the care of the employee's child or child of the employee's spouse or  
17 domestic partner whose illness or health condition requires treatment or supervision by the employee;  
18 or

19                           c. the care of a family member who suffers from a serious health  
20 condition.

21                   4. To the extent that Washington State law provides more extensive benefits  
22 for use of paid leave for family care, the Union and County agree that state law shall prevail.

23           **Section 6.9** An employee may take a total of up to eighteen weeks unpaid leave for his or her  
24 own serious health condition, and for family reasons as provided in Sections 6.8.G and 6.8.I  
25 combined, within a twelve month period. The leave may be continuous, which is consecutive days or  
26 weeks, or intermittent, which is taken in whole or partial days as needed. Intermittent leave is subject  
27 to the following conditions:

28           **A.** When leave is taken after the birth or placement of a child for adoption or foster

1 care, an employee may take leave intermittently or on a reduced leave schedule only if authorized by  
2 the employee's appointing authority.

3           **B.** An employee make take leave intermittently or on a reduced schedule when  
4 medically necessary due to a serious health condition of the employee or family member of the  
5 employee; and

6           **C.** If an employee requests intermittent leave or leave on a reduced leave schedule  
7 under Section B. above, that is foreseeable based on planned medical treatment, the appointing  
8 authority may require the employee to transfer temporarily to an available alternative position for  
9 which the employee is qualified and that has equivalent pay and benefits and that better  
10 accommodates recurring periods of leave than the regular position of the employee.

11           **Section 6.10** Use of donated leave shall run concurrently with the eighteen work week family  
12 medical leave entitlement.

13           **Section 6.11** The County shall continue its contribution toward health care during any unpaid  
14 leave taken under Section 6.9.

15           **Section 6.12** An employee who returns from unpaid family or medical leave within the time  
16 provided in this Article is entitled, subject to bona fide layoff provisions, to:

17           **A.** the same position he or she held when the leave commenced; or

18           **B.** a position with equivalent status, benefits, pay and other terms and conditions of  
19 employment; and

20           **C.** the same seniority accrued before the date on which the leave commenced.

21           **Section 6.13** Failure to return to work by the expiration date of the leave of absence may be  
22 cause for removal and result in termination of the employee from County service.

23 **ARTICLE 7: PAID LEAVES**

24           **Section 7.1** Employees covered by this Labor Agreement shall be eligible for the following  
25 paid leave benefits as provided for in King County Code 3.12.210, 3.12.215, 3.12.223, 3.12.225,  
26 3.12.240, 3.12.260, as amended.

27           **Section 7.2 Bereavement Leave (KCC 3.12.210):**

28           **A.** Employees eligible for paid leaves shall be entitled to three (3) working days of

1 bereavement leave per occurrence, due to death of members of their immediate family.

2           **B.** Employees eligible for leaves who have exhausted their bereavement leave shall be  
3 entitled to use sick leave in the amount of three (3) days for each instance of death when death occurs  
4 to a member of the employee's immediate family.

5           **C.** In cases of family death where no sick leave benefit exists, the employee may be  
6 granted leave without pay.

7           **D.** In the application of any of the foregoing provisions, when a holiday or regular day  
8 off falls within the prescribed period of absence, it shall not be charged against the employee's sick  
9 leave account nor bereavement leave credit.

10           **E.** Immediate family means any of the following relatives of the employee,  
11 employee's spouse or employee's domestic partner: spouse, domestic partner, grandparent, parent,  
12 child, sibling, child-in-law, parent-in-law, grandchild.

13           **Section 7.3 Organ Donor Leave (KCC 3.12.215):**

14           **A.** The appointing authority shall allow employees eligible for family leave, sick  
15 leave, vacation leave or leave of absence without pay who are voluntarily participating as donors in  
16 life-giving or life-saving procedures such as, but not limited to, bone marrow transplants, kidney  
17 transplants, or blood transfusions to take five days paid leave without having such leave charged to  
18 family leave, sick leave, vacation leave or leave of absence without pay; provided that the employee  
19 shall:

20                   1. Give the appointing authority reasonable advance notice of the need to take  
21 time off from work for the donation of bone marrow, a kidney, or other organs or tissue where there is  
22 a reasonable expectation that the employee's failure to donate may result in serious illness, injury,  
23 pain or the eventual death of the identified recipient.

24                   2. Provide written proof from an accredited medical institution, organization  
25 or individual as to the need for the employee to donate bone marrow, a kidney, or other organs or  
26 tissue or to participate in any other medical procedure where the participation of the donor is unique  
27 or critical to a successful outcome.

28           **B.** Time off from work for the purposes set out above in excess of five (5) working

1 days shall be subject to existing leave policies contracted in this Agreement.

2 **Section 7.4 Donation of Leaves (KCC 3.12.223):**

3 **A. Vacation leave hours.**

4 1. Any employee eligible for leave benefits may donate a portion of his or her  
5 accrued vacation leave to another employee eligible for leave benefits. Such donation will occur  
6 upon written request to and approval of the donating director(s), except that requests for vacation  
7 donation made for the purposes of supplementing the sick leave benefits of the receiving employee  
8 shall not be denied unless approval would result in a hardship for the Council.

9 2. The number of hours donated shall not exceed the donor's accrued vacation  
10 credit as of the date of the request. No donation of vacation hours shall be permitted where it would  
11 cause the employee receiving the transfer to exceed his or her maximum vacation accrual.

12 3. Donated vacation leave hours must be used within ninety calendar days  
13 following the date of donation. Donated hours not used within ninety days or due to the death of the  
14 receiving employee shall revert to the donor. Donated vacation leave hours shall be excluded from  
15 vacation leave payoff provisions contained in Article 5. For purposes of this section, the first hours  
16 used by an employee shall be accrued vacation leave hours.

17 **B. Sick leave hours.**

18 1. Any employee eligible for leave benefits may donate a portion of his or her  
19 accrued sick leave to another employee eligible for leave benefits upon written notice to the employee  
20 and Chief of Staff.

21 2. No donation shall be permitted unless the donating employee's sick leave  
22 accrual balance immediately subsequent to the donation is one hundred hours or more. No employee  
23 may donate more than twenty-five hours of his or her accrued sick leave in a calendar year.

24 3. Donated sick leave hours must be used within ninety calendar days.  
25 Donated hours not used within ninety days or due to the death of the receiving employee shall revert  
26 to the donor. Donated sick leave hours shall be excluded from the sick leave payoff provisions  
27 contained in Article 6, and sick leave restoration provisions contained in Article 6. For purposes of  
28 this section, the first hours used by an employee shall be accrued sick leave hours.

1 C. All donations of vacation and sick leave made under this section are strictly  
2 voluntary. Employees are prohibited from soliciting, offering or receiving monetary or any other  
3 compensation or benefits in exchange for donating vacation or sick leave hours.

4 D. All vacation and sick leave hours donated shall be converted to a dollar value  
5 based on the donor's straight time hourly rate at the time of donation. Such dollar value will then be  
6 divided by the receiving employee's hourly rate to determine the actual number of hours received.  
7 Unused donated vacation and sick leave shall be reconverted based on the donor's straight time  
8 hourly rate at the time of reconversion.

9 **Section 7.5 Leave for School Volunteer Service (KCC 3.12.225):**

10 The Supervisor shall allow the use of up to three days of sick leave each year to allow  
11 employees to perform volunteer services at the school attended by the employee's child, the  
12 employee's grandchild, the child of the employee's domestic partner, or child that resides in the  
13 employee's home. Employees requesting to use sick leave for this purpose shall submit such request  
14 in writing specifying the name of the school and the nature of the volunteer services to be performed.

15 **Section 7.6 Jury Duty (KCC 3.12.240):**

16 Any employee eligible for leave benefits who is ordered on a jury shall be entitled to his or her  
17 regular County pay; provided, that fees for such jury duty are deposited, exclusive of mileage, with  
18 the Finance and Business Operations Division of the Department of Executive Services. Employees  
19 shall report back to their work supervisor when dismissed from jury service.

20 **Section 7.7 Military Leave (KCC 3.12.260):**

21 A leave of absence for active military duty or active military training duty shall be granted to  
22 eligible employees in accordance with applicable provisions of state and/or federal law; provided, that  
23 a request for such leave shall be submitted to the appointing authority in writing by the employee and  
24 accompanied by a validated copy of military orders ordering such active duty or active training duty.

25 **Section 7.8 Unpaid Leaves of Absence:**

26 **A. Short-Term Leaves of Absence.** A leave of absence without pay for a period not  
27 exceeding sixty (60) consecutive days may be granted by the applicable Supervisor.

28 **B. Long-Term Leaves of Absence.** The Supervisor may grant a request for a leave

1 of absence for a period longer than sixty (60) days with the favorable recommendation of the  
2 applicable Manager. Long-Term leaves may be conditional or unconditional, with any conditions set  
3 forth in writing at the time that the leave is approved.

4 **Section 7.9 Supplemental Leave.** Employees covered by this Agreement may be granted up  
5 to ten (10) days of Supplemental Leave per calendar year, at the discretion of management, in  
6 recognition of workload obligations that require employees to work substantially in excess of the  
7 standard workweek on major bodies of work and pursuant to the Supplemental Leave Policy dated  
8 April 12, 1999. Supplemental leave shall be exhausted prior to the use of vacation leave.  
9 Supplemental leave may be used any time throughout the calendar year, provided that the employee  
10 and management specifically agree on the supplemental leave dates. There will be no cash out or  
11 carryover of unused Supplemental Leave to the following year.

## 12 **ARTICLE 8. WAGE RATES**

13 **Section 8.1 Pay Ranges:** The parties agree to the pay step progression on the applicable  
14 2010 ranges 128, 130, and 131 retroactive to the first regular pay period in January 2010 for calendar  
15 year 2010. Effective the first regular pay period following the implementation of this agreement,  
16 current bargaining unit members will be step placed on the 2011 King County Salary Table pay  
17 ranges 72, 76 and 79 pursuant to attached Addendum "A" to this agreement.

18 Senior – 72

19 Principal – 76

20 Senior Principal - 79

21 Subsequent step increases shall be annual and effective January 1 of each year, beginning  
22 January 1, 2012 unless the employee received a performance evaluation of "below standards" for the  
23 preceding year in which case the employee shall remain at the existing step.

24 The parties agree that the classification titles shall be compensated at the pay ranges and steps  
25 as shown in attached Addendum "A."

### 26 **Section 8.2 Cost of Living Adjustment:**

27 The County agrees to apply the 2010 Cost of Living Adjustment of two percent (2%)  
28 retroactive effective January 1, 2010 for all bargaining unit employees. The parties have negotiated a

1 Memorandum of Agreement titled "Memorandum of Agreement by and between King County and  
2 International Brotherhood of Teamsters Local 117 Addressing the 2011 Budget Crisis", document  
3 code: 454C0111\_000U0310\_COLA-2011\_454 (Addendum B). The provisions of that Memorandum  
4 of Agreement are incorporated into this Collective Bargaining Agreement. For illustrative purposes,  
5 the provisions of the Memorandum of Agreement pertaining to cost of living adjustments for the  
6 years 2012 through 2013 are:

7 **A. 2012 COLA**

8 Employees shall be eligible to receive 90% of the annual average growth rate of the bi-  
9 monthly Seattle-Tacoma-Bremerton Area Consumer Price Index for Urban Wage Earners and  
10 Clerical Workers (CPI-W, July of the previous year to June of the current year). Zero floor and no  
11 ceiling.

12 **B. 2013 COLA**

13 Employees shall be eligible to receive 95% of the annual average growth rate of the bi-  
14 monthly Seattle-Tacoma-Bremerton Area Consumer Price Index for Urban Wage Earners and  
15 Clerical Workers (CPI-W, July of the previous year to June of the current year). Zero floor and no  
16 ceiling.

17 The parties agree when significant shifts in economic and fiscal conditions occur during the  
18 term of this agreement, the parties agree to reopen negotiations for COLA when triggered by either an  
19 increase in the King County unemployment rate of more than 2 percentage points compared with the  
20 previous year or a decline of more than 7% in County retail sales as determined by comparing current  
21 year to previous year. Data will be derived from Washington State Department of Revenue. By no  
22 later than July 30th of each year of this Agreement, the county will assess whether the economic  
23 measurements listed above trigger contract reopeners on COLA for the subsequent year.

24 **Section 8.3 Temporary Assignment:** Bargaining unit members may be assigned to fill a  
25 position on a temporary basis or perform duties of a higher classification on a temporary basis  
26 pursuant to Council policy issued October 16, 2006, as amended.

27 **ARTICLE 9: MEDICAL, DENTAL AND LIFE INSURANCE**

28 The County will provide a medical, dental and life insurance plan for all benefit eligible

1 employees; such plans, including any changes thereto, to be as negotiated by the County and the  
2 Union through the Joint Labor Management Insurance Committee.

3 **ARTICLE 10: HOURS OF WORK**

4 **Section 10.1 Workweek.** The standard work week shall consist of forty (40) hours per week,  
5 exclusive of lunch periods.

6 **Section 10.2 Workday.** The establishment of reasonable work schedules is vested within the  
7 purview of the Council management and may be changed from time to time. The County agrees to  
8 make a good faith effort to accommodate employees' requests for alternative work schedules/flex  
9 time, consistent with efficient and effective County operations.

10 **ARTICLE 11: GRIEVANCE PROCEDURE**

11 **Section 11.1 Grievance/Arbitration/Mediation:** The County recognizes the importance  
12 and desirability of settling grievances promptly and fairly in the interest of continued good employee  
13 relations and morale and to this end the following procedure is outlined. To accomplish this, every  
14 effort will be made to settle grievances at the lowest possible level of supervision.

15 Employees will be unimpeded and free from restraint, interference, coercion, discrimination  
16 or reprisal in seeking adjudication of their grievances.

17 **A. Definition.**

18 Grievance - A claim by an employee or the Union that the terms of this Agreement have been  
19 violated and/or a dispute exists concerning the proper application or interpretation of this Agreement.

20 **B. Procedure.**

21 **Step 1.** A grievance shall be verbally presented by the aggrieved employee (and  
22 his/her representative if the employee wishes) to the Chief of Staff within ten (10) working days of  
23 the occurrence of the events giving rise to such grievance, or, if the employee was unaware of said  
24 events, the grievance shall be verbally presented to the Chief of Staff within ten (10) days of when a  
25 reasonable employee would have become aware of the events. The Chief of Staff shall gain all  
26 relevant facts and shall attempt to adjust the matter and notify the employee within ten (10) working  
27 days. If a grievance is not presented in writing to the next level within ten (10) working days of the  
28 decision of the Chief of Staff, it shall be presumed resolved and the union shall forfeit any further

1 right to advance the grievance.

2           **Step 2.** If after thorough evaluation, the decision of the Chief of Staff has not resolved  
3 the grievance to the satisfaction of the employee, the grievance may be presented to the Chair of the  
4 Employment Committee. All letters, memoranda and other written materials previously submitted to  
5 lower levels of supervision shall be made available for the review and consideration of the Chair of  
6 the Employment Committee. He/she may interview the employee and/or his/her representative and  
7 receive any additional related evidence which he/she may deem pertinent to the grievance. He/she  
8 shall make his/her written decision available within ten (10) working days and, in the event such  
9 written decision is not available within ten (10) working days, the grievance shall be moved to the  
10 next step. If the grievance is not pursued to the next higher level within fifteen (15) working days of  
11 the decision of the Chair of the Employment Committee, it shall be presumed resolved and the union  
12 shall forfeit any further right to advance the grievance.

13           **Step 3.** If the Chair of the Employment Committee's disposition of the grievance is  
14 not satisfactory to the employee and Union, or an action or decision of the Chair of the Employment  
15 Committee is the cause of the grievance, the Union may, in writing, refer the grievance to the  
16 Employment Committee within ten (10) working days following receipt of the Chair of the  
17 Employment Committee's decision or, in the case of a grievance against an action or decision of the  
18 Chair of the Employment Committee, within ten (10) working days of the event giving rise to such  
19 grievance. The Employment Committee will conduct a grievance hearing within fifteen (15) working  
20 days of receipt of the grievance. The employee/Union and the Chair of the Employment Committee  
21 or designee shall be provided the opportunity to present whatever information they consider relevant.  
22 Strict rules of evidence need not be followed in conducting the hearing.

23           The Employment Committee shall render a final resolution within fifteen (15) working days  
24 of the conclusion of the hearing.

25           **Step 4.** Either signatory party may request arbitration within fifteen (15) working days  
26 of the conclusion of Step 3. A request for arbitration must be submitted in writing to the King  
27 County Labor Relations Director or designee, and to the Council Chair, or to the Union representative  
28 if the County Council requests arbitration. The arbitration request must specify:

- 1 a) Identification of section(s) of Agreement allegedly violated;
- 2 b) Details or nature of the violation;
- 3 c) Position of party who is referring the grievance to arbitration;
- 4 d) Questions which the arbitrator is being asked to decide; and
- 5 e) Remedy sought.

6 The parties shall then select a disinterested party to serve as an arbitrator. In the event that the  
7 parties are unable to agree upon an arbitrator, then the arbitrator shall be selected from a panel of  
8 seven arbitrators furnished by the Federal Mediation and Conciliation Services or another agency if  
9 the parties agree. The arbitrator will be selected from the list by both the County representative and  
10 the Union, each alternately striking a name from the list until only one name remains. The arbitrator  
11 shall be asked to render a decision within 30 days of the close of the hearing and the decision of the  
12 arbitrator shall be final and binding on both parties.

13 The arbitrator shall have no power to change, alter, detract from or add to the provisions of  
14 this Agreement, but shall have the power only to apply and interpret the provisions of this Agreement  
15 in reaching a decision.

16 The arbitrator's fee and expenses and any court reporter's fee and expenses shall be borne  
17 equally by both parties. Each party shall bear the cost of any witnesses appearing on that party's  
18 behalf. Regardless of the outcome of the arbitration, each party shall bear the cost of its own legal  
19 representation.

20 **Section 11.2 Union Representation.** In the event the Employer requires an employee to  
21 attend a meeting for purposes of questioning an employee with respect to an incident which may lead  
22 to termination of that employee, should the employee desire Union representation in said matter,  
23 he/she shall notify the Employer at that time and shall be provided a reasonable time to arrange for  
24 Union representation.

25 **Section 11.3 Extension of Timeframes.** The parties may extend the above described  
26 deadlines in writing by mutual agreement of the parties.

27 **Section 11.4 Election of Remedies.** An employee who is covered by this Agreement has  
28 access either to the grievance procedure herein, or the grievance procedure provided the Council

1 Employment Committee. Selection of one procedure will preclude access to the other to resolve the  
2 grievance. Selection must be made at the conclusion of Step 1 of the procedure set forth by the  
3 Employment Committee or at the conclusion of Step 2 of the grievance procedure in Article 11. The  
4 employee's selection is final.

5 **ARTICLE 12: EQUAL EMPLOYMENT OPPORTUNITY**

6 The County and the Union shall not unlawfully discriminate against any individual employees  
7 with respect to compensation, terms, conditions or privileges of employment by reason of race, color,  
8 sex, religion, national origin, religious belief, marital status, age, sexual orientation, gender identity,  
9 political ideology, ancestry or disability. Allegations of unlawful discrimination shall not be a proper  
10 subject for adjudication under the grievance arbitration procedure of Article 11 of this Agreement.  
11 Grievances involving allegations of discrimination that are not resolved through the grievance  
12 procedure of Article 11 may be referred by the grievant to the appropriate government agency.

13 **ARTICLE 13: SAVINGS CLAUSE**

14 Should any part hereof or any provision herein contained be rendered or declared invalid by  
15 reason of any existing or subsequently enacted legislation or by any decree of a court of competent  
16 jurisdiction, such invalidation of such part or portion of this Agreement shall not invalidate the  
17 remaining portions hereof; provided, however, upon such invalidation the parties agree to meet and  
18 negotiate such parts or provisions affected. The remaining parts or provisions shall remain in full  
19 force and effect.

20 **ARTICLE 14: WORK STOPPAGES AND EMPLOYER PROTECTION**

21 **Section 14.1** The Employer and the Union agree that the public interest requires efficient and  
22 uninterrupted performance of all County services and to this end pledge their best efforts to avoid or  
23 eliminate any conduct contrary to this objective. Specifically, the Union shall not cause or condone  
24 any work stoppage, including any strike, slowdown, or refusal to perform any customarily assigned  
25 duties, sick leave absence which is not bona fide, or other interference with County functions by  
26 employees under this Agreement and should same occur, the Union agrees to take appropriate steps to  
27 end such interference. Any concerted action by any employees in any bargaining unit shall be  
28 deemed a work stoppage if any of the above activities have occurred.

1           **Section 14.2** Upon notification in writing by the County to the Union that any of its members  
2 are engaged in a work stoppage, the Union shall immediately, in writing, order such members to  
3 immediately cease engaging in such work stoppage and provide the County with a copy of such order.  
4 In addition, if requested by the County, a responsible official of the Union shall publicly order such  
5 Union employees to cease engaging in such a work stoppage.

6           **Section 14.3** Any employee participating in such work stoppage or in other ways committing  
7 an act prohibited in this article shall be considered absent without leave. The County may consider  
8 such absence a resignation. Such employees are also subject to discharge, suspension, or other  
9 disciplinary action.

10 **ARTICLE 15: WAIVER CLAUSE**

11           The parties acknowledge that each has had the unlimited right within the law and the  
12 opportunity to make demands and proposals with respect to any matter deemed a proper subject for  
13 collective bargaining. The results of the exercise of that right and opportunity are set forth in this  
14 Agreement. Therefore, the County and the Union, for the duration of this Agreement, each agree to  
15 waive the right to oblige the other party to bargain with respect to any subject or matter not  
16 specifically referred to or covered in this Agreement.

17 **ARTICLE 16: REDUCTION-IN-FORCE/LAYOFF REHIRS**

18           In the event the County determines that a layoff is necessary, the County shall select the  
19 employee to be laid-off based upon the knowledge, skills and abilities of the employee, the needs of  
20 the employer, and the performance of employees. In the event the application of these factors results  
21 in two employees being substantially equal, seniority will be used as a tiebreaker. The weight to be  
22 given these factors is within the reasonable discretion of the County, and may only be overturned  
23 through the grievance procedure upon a showing that the County's determination was arbitrary and  
24 capricious.

25           An employee that has been laid-off will be placed on a recall list for a period of two (2) years  
26 from the date of layoff. In filling a vacant bargaining unit position, the County will offer it to an  
27 employee on the recall list prior to hiring from the outside, assuming the employee on the list is  
28 qualified for the position. In the event more than one employee on the recall list is qualified for the

1 position, the County may determine which employee will be offered the opening.

2 **ARTICLE 17: PAST PRACTICE**

3 The parties agree that this Agreement will constitute the whole and entire Agreement between  
4 the parties. Further, that any past practice which is not specifically and expressly contained within the  
5 terms of this Agreement will be considered abolished and will no longer be considered a precedent.

6 **ARTICLE 18: MISCELLANEOUS**

7 **Section 18.1 Union Leave.** An employee elected or appointed to office in the Union which  
8 requires a part or all of their time shall be given leave of absence up to one (1) year without pay upon  
9 application.

10 **Section 18.2 Reimbursement for Personal Transportation.** All employees who have been  
11 authorized to use their own transportation on County business shall be reimbursed at the rate  
12 established through Ordinance by the County Council.

13 **Section 18.3 Bulletin Boards and Use of Equipment.** The employer agrees to permit the  
14 Union shop stewards and business representatives to post on County bulletin boards the  
15 announcement of meetings, election of officers, and any other similar official material from the  
16 Union, providing there is sufficient space, beyond what is required by the County for "normal"  
17 business operations, and provided further that such material is neither political nor inflammatory, as  
18 determined by the employer.

19 Union shop stewards and business representatives shall be allowed to post electronic mail  
20 notices on the County system if the notices meet the same requirements listed above. In addition,  
21 such representatives may use the County electronic mail system for communications related to  
22 contract administration. In no circumstances shall use of the County equipment interfere with County  
23 operations. The Union recognizes that there is no assurance of privacy or confidentiality for  
24 information sent through the County system.

25 **Section 18.4 Union Access.** Authorized representatives of the Union may have reasonable  
26 access to its members in County facilities for transmittal of information or representation purposes  
27 before work, after work, during lunch breaks, or other regular breaks, or at any reasonable time as  
28 long as the work of the County employees and services to the public are unimpaired. Prior to

1 contacting members in County facilities, such authorized agents shall make arrangements with the  
2 Chief of Staff.

3 **Section 18.5 Safety and Health.** In the event an employee discovers or identifies an unsafe  
4 condition, the employee will immediately notify the supervisor. Employees will not be disciplined  
5 for reporting unsafe conditions. No employee shall be required to use equipment which is unsafe, or  
6 to work in an unsafe environment.

7 **Section 18.6 Bus Pass.** The County agrees to maintain the current bus pass benefit for  
8 eligible employees for the life of this Agreement.

9 **Section 18.7 Job-Related Training.** The County will pay all fees and travel expenses for  
10 required job-related training, as approved by the employer.

11 **Section 18.8 Employee Access.** The employee may examine the employee's personnel file.  
12 Employees upon request may receive one copy from their personnel file copied at no cost. Material  
13 relating to job performance or personal character will be provided to the employee prior to placement  
14 in the personnel file. The employee may challenge the propriety of including it in the file, and/or  
15 submit the employee's own documentation to be attached to the challenged material. Employees may  
16 request to have materials that reflect favorably on their performance or character included in their  
17 personnel file.

18 **Section 18.9. Disclosure.** An employee whose personnel file is subject to a public disclosure  
19 demand will be notified of the demand on a timely basis, as provided in the King County Personnel  
20 Records Management Guidelines.

## 21 **ARTICLE 19: CLASSIFICATIONS**

22 The determination of which classification an employee will be placed will be made by the  
23 County. While job duties and responsibilities will be the primary factor determining the appropriate  
24 classification for employees, it is also recognized that the Employer may retain what it deems to be an  
25 appropriate distribution of employees in each classification. After an employee has been in a  
26 classification for four (4) years, and if there has been a significant and material change in the duties  
27 and responsibilities of the employee, and that the change is permanent rather than temporary, the  
28 employee may file a request with the Chief of Staff (or designee) to be reclassified into the next

1 higher classification. The request must include supporting documentation, using the PDQ format.  
2 The Chief of Staff will have sixty (60) days to review the request and respond to the employee.

3 In the event the employee is not satisfied with the determination of the Chief of Staff, the  
4 employee may file an appeal, in writing, to the Chair of the King County Council's Employment  
5 Committee, with a copy to the Chief of Staff. The Chief of Staff (or designee) will thereafter request  
6 that the King County Department of Human Resources conduct a review of the employee's job  
7 duties, and responsibilities, and make a recommendation on whether a re-classification is appropriate.  
8 The recommendation, and supporting material, will be provided to the King County Council's  
9 Employment Committee. The Committee will have thirty (30) days to review the recommendation  
10 and make a determination. In the event the employee is not satisfied with the decision of the  
11 Employment Committee, the matter may be appealed to the full King County Council. The decision  
12 of the Council may only be appealed through a non-binding fact-finding process. In order to initiate  
13 the fact finding process, the Union must provide the written notice to the County within fourteen (14)  
14 calendar days of the Council's decision. If the parties are unable to agree upon a fact-finder, they will  
15 request a panel from the Public Employment Relations Commission. The fact-finder will be charged  
16 with making a non-binding recommendation to the parties on whether the employee's classification  
17 should be changed, consistent with the above criteria. The fact-finding process shall be determined  
18 by the fact-finder, and will be conducted fairly and expeditiously. Prior to issuing a formal  
19 recommendation, the fact finder will meet informally with the parties to inform them of his or her  
20 findings. Thereafter, the parties will have two (2) weeks to attempt to reach an agreement. If no  
21 agreement is reached, the fact finder shall issue his or her non-binding decision. The cost of the fact-  
22 finder shall be borne equally by the parties, while any other costs shall be the responsibility of the  
23 party incurring them.

24 The County may initiate a review of the classification of an employee to determine whether  
25 the job duties and responsibilities of the position should result in the employee being reduced to a  
26 lower classification. The review shall be conducted by Human Resources. The review and  
27 recommendation, and supporting material, will be provided to the King County Council's  
28 Employment Committee. The Committee will have thirty (30) days to review the recommendation

1 and make a determination. In the event the employee is not satisfied with the decision of the  
2 Employment Committee, or if the Employment Committee is unable to resolve the matter, it may be  
3 appealed to the full King County Council. While the County may not appeal the determination of the  
4 Council, the employee may pursue the matter through the grievance procedure.

5 **ARTICLE 20: PENSION**

6 In the event that the bargaining unit elects to participate in the Western Conference of  
7 Teamsters Pension Trust ("Trust") the Employer agrees to adopt the standard County language  
8 regarding contributions to the Trust, with a contribution rate designated by the bargaining unit, with a  
9 start date to be determined by the parties.

10 In the event the Western Conference of Teamsters should impose any penalty or surcharge on  
11 hourly contributions, all such amounts shall be paid by the Employer, with an equivalent payroll  
12 deduction made to the wages specified in this Agreement.





5 by either party upon the other at least sixty (60) days prior to the expiration date.

WHEREAS, the County is experiencing a financial crisis with a projected General Fund revenue shortfall of \$60 million;

WHEREAS, effective January 1, 2011, the County will eliminate hundreds of positions;

WHEREAS, the parties have an interest in preserving as many positions as possible;

WHEREAS, the employees represented by International Brotherhood of Teamsters Local 117 - Legislative Analysts - King County Council

454	Teamsters Local 117	Legislative Analysts - King County Council

WHEREAS, the national financial crisis, the County's structural financial imbalance, and declining revenues have significantly impacted the County's ability to pay Cost of Living adjustments to its employees;

WHEREAS, the parties will through this Agreement help to preserve essential services and reduce layoffs necessary during 2011.

NOW THEREFORE, King County and International Brotherhood of Teamsters Local 117 agree as follows.

1. The parties have negotiated that all employees covered by collective bargaining agreements that are open on the subject of 2011 Cost of Living pay adjustments and represented by the aforementioned Unions will not receive a 2011 Cost of Living pay adjustment.

The parties agree that wages will be increased by percentage amounts shown below:

**A. 2012 COLA**

Employees shall be eligible to receive 90% of the annual average growth rate of the bi-monthly Seattle-Tacoma-Bremerton Area Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W, July of the previous year to June of the current year). Zero floor and no ceiling.

## ADDENDUM B

### **B. 2013 COLA**

Employees shall be eligible to receive 95% of the annual average growth rate of the bi-monthly Seattle-Tacoma-Bremerton Area Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W, July of the previous year to June of the current year). Zero floor and no ceiling.

### **C. 2014 COLA**

Employees shall be eligible to receive 95% of the annual average growth rate of the bi-monthly Seattle-Tacoma-Bremerton Area Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W, July of the previous year to June of the current year). Zero floor and no ceiling.

The parties agree when significant shifts in economic and fiscal conditions occur during the term of this agreement, the parties agree to reopen negotiations for COLA when triggered by either an increase in the King County unemployment rate of more than 2 percentage points compared with the previous year or a decline of more than 7% in County retail sales as determined by comparing current year to previous year. Data will be derived from Washington State Department of Revenue. By no later than July 30th of each year of this agreement, the county will assess whether the economic measurements listed above trigger contract reopeners on COLA for the subsequent year.

2. Employees covered by this Agreement will be eligible to receive, in 2011, 2012, 2013 and 2014, other forms of compensation adjustments as provided for in their collective bargaining agreement.

3. As determined by the County, savings generated by forgoing a 2011 Cost of Living pay adjustment shall be applied by the County in such a way as to reduce the loss of jobs held by bargaining unit members covered by the terms of this Agreement.

4. The County agrees to maintain the benefits negotiated in the Joint Labor Management Insurance Committee for 2011 through 2012.

5. The parties acknowledge that all parties have fulfilled their obligations to engage in collective bargaining over the subjects contained in this Agreement.

6. The parties acknowledge that this Agreement is subject to approval by the King County Council and ratification by the membership of the aforementioned Unions.


7. Any dispute regarding the interpretation and/or application of this Agreement shall be handled pursuant to the terms of the applicable Union's grievance procedure, provided that if more than one bargaining unit has the same or similar dispute, the grievances shall be consolidated.



CLARIFYING THE PARTIES' COLLECTIVE BARGAINING AGREEMENT

WHEREAS, King County and the International Brotherhood of Teamsters, Local Union No. 117, have negotiated a collective bargaining agreement ("the CBA") concerning Legislative Analysts working at the King County Council that has been ratified by bargaining unit members and submitted by the County Executive for Council approval, and

WHEREAS, certain provisions of the CBA require clarification in order to ensure the intent of the parties is clear and is properly implemented in a manner consistent with the parties' intent;

NOW, THEREFORE, King County and the International Brotherhood of Teamsters, Local Union No. 117, agree as follows.

1. With regard to Section 8.1 of the CBA, the intent of the parties is as follows:

A. For calendar year 2010, the parties agree to the pay step progression in the applicable ranges 128, 130, and 131 of the Legislative Branch 2010 Exempt Salary Schedule, retroactive to the first regular pay period in January 2010, including a 2.0 percent cost of living increase for 2010.

B. Effective January 1, 2011, bargaining unit members in the classification "Legislative Analyst - Senior" will be placed in Range 72 of the 2011 King County 10 Step Annual/FLSA Exempt Squared Schedule (with Zero COLA for 2011) at the step with the salary closest to, but not less than, the member's salary determined pursuant to section 1.A above. Immediately upon placement at the appropriate step of Range 72, each of these bargaining unit members will receive a step increase unless the member is already at the top step of Range 72.


C. Effective January 1, 2011, bargaining unit members in the classifications "Principal Legislative Analyst" and "Principal Legislative Analyst - Senior" will be placed in Ranges 76 and 79, respectively, of the 2011 King County 10 Step Annual/FLSA Exempt Squared Schedule (with Zero COLA for 2011) at the step with the salary closest to, but not less than, the member's salary determined pursuant to section 1.A above. Except for that placement, these bargaining unit members will not receive a step increase for 2011.

## ADDENDUM C

D. Beginning January 1, 2012, each bargaining unit member will receive an annual step increase unless the member received a performance evaluation of "below standards" for the preceding year or is already at the top step of the applicable pay range.

2. Consistent with Section 8.2 of the CBA and the Memorandum of Agreement that is Addendum B to the CBA, bargaining unit members will not receive a cost of living increase for 2011.



The scope of this bargaining unit is defined by the classifications that are listed in Addendum A of the current Collective Bargaining Agreement ("CBA"), effective September 11, 2009, through June 30, 2013.
2. In order to improve the delivery of services to Council members, as well as to ensure accurate and timely work, the Council wants to designate some employees as Team Leaders. It is intended that this will be a pilot project.
3. The parties have discussed this matter and agreed to the following.


**Agreement:**


- c. Assigning work (in consultation with lead staff) to committee analysts and support staff.





This letter transmits an ordinance that will enable King County to provide fair wages, hours, and working conditions to employees who provide essential services to the King County Council.

The enclosed ordinance, if approved, will ratify the International Brotherhood of Teamsters Local 117 (Legislative Analysts - King County Council) collective bargaining agreement for the period of July 1, 2013, through June 30, 2014, which is a one year extension of the current collective bargaining agreement.

This agreement covers 17 employees that work for the King County Council. The employees of this bargaining unit conduct qualitative and quantitative analysis of policy issues, assist with the development and implementation of Council-directed initiatives, and participate in the Council's annual budget adoption process by analyzing budgets and financial plans.

The enclosed collective bargaining agreement continues to provide for bargaining unit employees to be subject to just cause suspension and discharge but if challenged, the County's judgment will be upheld unless it is arbitrary or capricious. In cases where the County's determination is based on a documented process of performance management, it may not be challenged. The agreement provides for the efficient assignment of bargaining unit work to persons outside the bargaining unit and provides further that layoff determinations shall be based on knowledge, skills and abilities of the employee, the performance of the employee, and the needs of the employer to perform duties of bargaining unit employees.

This agreement contains significant improvements in efficiency, accountability, and productivity for the County by incorporating standardized biweekly payroll practices to the County administration of personal holiday accruals, vacation leave accrual limits, and sick leave accrual.

This collective bargaining agreement furthers the County's Strategic Plan by attracting and retaining a quality workforce by providing fair market wages and working conditions.

There are no changes to the wage schedule, and the cost-of-living adjustment for 2014 follows the standard County settlement agreed to with other labor organizations.
