## SERVICE CHANGE:


Eliminate the part of the route north of Madison Street to reduce network duplication with Route 13 between downtown Seattle and Queen Anne.

Shift route from Madison Street to Seneca Street to consolidate service with Route 12 on First Hill.

Improve service levels to about every 10 minutes in the peak periods and about every 12 minutes during midday weekdays.

Discontinue service at approximately12:00 PM everyday.

Alternative service will be provided by routes 13 and 29 between upper Queen Anne and downtown Seattle via Uptown, and Route 1 and the RapidRide D Line between Uptown and downtown Seattle.

Discontinue night service at approximately12:00 AM everyday.



Reduce peak service levels to five trips in the morning and three trips in the afternoon.

Routes 2, 10, 11, and 43 will provide alternative service on Capitol Hill and First Hill.

Alternative service will be provided by Route 107 on Beacon Hill, Route 36 between Beacon Hill and the Chinatown-International District, and the First Hill Streetcar between the Chinatown-International District, First Hill and Capitol Hill.
