11	department of public defense	has created a need for contiguous space to
12	accommodate the new county	employees. Predevelopment work will
13	determine the feasibility of the	ne adaptive reuse of the Yesler Building as a
14	cost-efficient, long-term solu	tion for colocating this vital public service.
