Dear Councilmember Phillips:

I am pleased to notify you that under the process set forth in King County Code Section 2.60.026(B), I have appointed Lorinda Youngcourt effective January 19, 2015, as the County Public Defender and Director of the King County Department of Public Defense. Additionally, I am transmitting a motion for Council's consideration to approve Ms. Youngcourt's appointment. A confirmation packet will be transmitted to the Council shortly.

Using the process designed by the Council, we conducted a nationwide search with the aid of Karras Consulting and the eleven members of the Public Defense Advisory Board for the position that will lead the new organizational structure approved by voters in 2013. The Board sought input from stakeholders, including public defenders and the union that represents our staff, the Service Employees International Union, about the attributes and competencies critical for the leader of the new organization to possess. I made my selection from the names forwarded to me from the Board.

Ms. Youngcourt has a deep commitment to indigent defense, and proven skills and expertise in protecting the rights of the accused as guaranteed under the Constitution. Ms. Youngcourt's national reputation for upholding the highest traditions of public defense in King County aligns well with the County's strategic goal of providing service excellence and accessible justice systems for all.

Ms. Youngcourt received her law degree from Indiana University School of Law and has extensive experience in defending clients facing the death penalty in both state and federal courts. She is a nationally recognized leader through her work with the National Association of Public Defenders and the National Association of Criminal Defense Lawyers. She currently chairs the Indiana Public Defender Council, a statutory agency that provides support services to the state's 1,300 public defenders and statewide leadership on issues of criminal justice. Executive names Lorinda Youngcourt as King County's first Public Defender

December 8, 2014

Summary

Lorinda Youngcourt has extensive experience in defending clients facing the death penalty in both state and federal courts. She is currently the Chief Public Defender for Lawrence County, Ind., and was named by Executive Constantine as King County's first Public Defender.

Story

Following a national search, King County Executive Dow Constantine accepted the recommendation of a public defense advisory board and named Lorinda Youngcourt as King County's first Public Defender under a new organizational structure approved by voters. Youngcourt was the Chief Public Defender for Lawrence County, Ind.

"Lorinda has a deep commitment to indigent defense, with the skills and expertise to protect the rights of the accused as guaranteed under the Constitution," said Executive Constantine. "With the amount of change brought about by a high court ruling and class-action settlement, she brings a national reputation for excellence to the task of leading our department and upholding the highest traditions of public defense in King County."

Under a process spelled out in the County Code, the 11-member King County Public Defense Advisory Board submitted the names of candidates to the County Executive. Advisory Board Chair Marc Boman said his group looks forward to working with Youngcourt.

"Ms. Youngcourt was one of the names we submitted and we are pleased to welcome her as the new director," said Boman. "She brings to the position more than 25 years of experience in criminal defense, as well as experience building and leading a new countylevel public defender agency." Youngcourt received her law degree from Indiana University School of Law and has extensive experience in defending clients facing the death penalty in both state and federal courts, and is a leader on the national level through the National Association of Public Defenders and the National Association of Criminal Defense Lawyers.

Youngcourt chairs the Indiana Public Defender Council, a statutory agency that provides support services to the state's 1,300 public defenders and statewide leadership on issues of criminal justice. She is currently the Chief Public Defender for the Lawrence County Public Defender Agency in Bedford, Ind., where she created a new office of indigent defense services to replace an antiquated system where underpaid private attorneys were hired and fired by local judges.



"I'm deeply honored for the opportunity to bring my strong values and experience to King County's

public defense system," said Youngcourt. "King County is known throughout the country for its committed staff, strong advocacy, and client-centered approach. I look forward to working with the staff, the advisory board, the Executive, and the County Council in taking public defense to the next level in King County."

Youngcourt succeeds interim Public Defender David Chapman, who did not seek the permanent position.

"Dave's vision, steady leadership, and skillful management helped us all make the transition to this new model for delivering services to the public," said Executive Constantine. "Dave set a strong foundation for the future of public defense in King County. He leaves a lasting legacy, and he has my eternal gratitude."

Youngcourt begins her new position on January 20, 2015. Her appointment is subject to confirmation by the King County Council.


About the Department of Public Defense

The <u>King County Department of Public Defense</u> provides legal services to approximately 15,000 indigent clients a year who face felony or misdemeanor charges, civil commitment proceedings, dependency proceedings and other criminal or civil issues. The department's social workers, investigators, paralegals and other staff also provide client support and advocacy.

Public defense services in the County were historically contracted out to four nonprofit agencies, a system that changed after a class-action lawsuit resulted in a state Supreme Court ruling that found the nonprofits were "arms and agencies" of the County. The

Metropolitan King County Council created the new Department of Public Defense in May 2013, and on July 1, 2013, the 350 employees at the four nonprofits became county employees.

In November 2013, voters approved an amendment to the King County Charter making the new department a permanent part of County government, establishing the position of chief Public Defender to direct the department, and creating a Public Defense Advisory Board to advise the department, review its proposed budget, issue an annual report on the state of the county's public defense system, and forward candidates for the position of Public Defender whenever it becomes vacant.



Class Summary

The responsibilities of this classification include directing, planning and organizing the operations of the Department of Public Defense in order to advance departmental independence and ensure quality public defense services are delivered in an efficient manner. The incumbent fosters and promotes access to justice and equity in the criminal justice system.

Distinguishing Characteristics

This is a single level classification. The incumbent provides strategic direction and leadership to the divisions within the Department of Public Defense and ensures the department follows the Washington State Standards for Indigent Defense Services. The Director of Public Defense is responsible for the providing supervision and guidance to staff; developing and administering the department's budget; and planning, administering, and evaluating policies, standards, and guidelines for the provision of defense services.

Examples of Duties

- 1. Ensure the department provides effective delivery of public defense services and follows the Washington State Standards for Indigent Defense Services.
- Develop and execute goals, strategic direction and policies, and short and long term objectives; design and implement advocacy and communication activities that advance public defense priorities. Ensure the American Bar Association Ten Principles for a Public Defense Delivery System guides the development of department standards for legal defense representation.
- 3. Foster and promote system improvements, access to justice and equity in the criminal justice system.
- 4. Establish and maintain an assigned counsel panel, which includes attorneys acceptable to the department who are eligible to participate in the defense of persons eligible for services through the department; assigns cases to assigned counsel where conflicts of interest or other special circumstances exist.
- 5. Direct the preparation and administration of the department's annual budget. Evaluate and forecast service delivery levels and department expenses for service delivery, contractors, assigned counsel and administration. Advocates for adequate funding.
- 6. Represent the department and participates at forums in which a defense perspective is required. Resolve politically sensitive issues associated with the department's strategic goals.
- 7. Work collaboratively with the public defense advisory board and provide relevant, nonpriviledged information to the board upon its reasonable request.
- 8. Ensure resources are deployed appropriately and efficiently to maximize outcomes.
- 9. Perform other duties as assigned.

Knowledge/Skills

Knowledge of principles, practices and procedures related to the legal profession and the provision of legal representation to defendants accused of criminal acts

Knowledge of administrative and managerial principles and practices, including goal setting, program development, implementation and evaluation, and the management of employees through multiple levels of supervision

Knowledge of county codes and state statutes relating to criminal law and procedures, judicial procedures and rules of evidence

Knowledge of principles of criminal law and of appeal procedures as they relate to the violations of municipal ordinances of state statutes; principles, methods, materials and practices of legal research; the methods and practices of pleading civil and criminal cases and of effective techniques in the presentation of cases in court

Knowledge of the principles of public administration, including: human resources management, fiscal management, and accounting

Ability to establish and maintain cooperative work relationships with members of the legal profession, public officials, and court personnel

Ability to prepare legal research and present statements of fact, argument, and recommendations concerning public defense systems and services

Ability to communicate effectively with a variety of individuals representing diverse cultures and backgrounds and function calmly in situations which require a high degree of sensitivity, tact and diplomacy

Ability to establish effective working relationships with management, employees, employee representatives, and the public representing diverse cultures and backgrounds

Ability to work independently and as a team member

Skill in using current office software programs including word processing, spreadsheet, database and email

Graduation from an American Bar Association accredited law school and seven years experience as an attorney, primarily practicing criminal defense
