10	County utilities technical review	v committee.
11	3. The utilities technical review	committee has approved the Mariani
12	Water System's franchise applic	ation as meeting the requirements of
13	K.C.C. 6.27.060 and 13.24.010.	
14	4. The council has scheduled, n	oticed and conducted a public hearing
15	regarding the Mariani Water Sy	stem's application for a right-of-way
16	franchise on the 2nd day of Sep	tember, 2014, as required by RCW
17	36.55.040 and K.C.C. 6.27.050.

19	SECTION 1. The metropolitan King County council, having determined that the	
20	Mariani Water System's application meets the criteria for the granting of a water	
21	franchise and that the grant is in the best interests of the public, does hereby approve the	
22	attached franchise agreement and authorizes the King County executive to execute the	
23	agreement.	
24	If within forty-five days after the granting of the franchise, the applicant fails to	
25	sign the written acceptance incorporated in this ordinance, then the rights and privileges	
26	granted in this ordinance shall be forfeited and the franchise shall be null and void.	
27	If this franchise is accepted by the applicant as provided herein and comes into	
28	force and effect, then this franchise shall replace the Mariani Water System's previous

- water franchise, specifically No. 6672, and such earlier franchise shall be thereafter null 29
