Ordinance 18000 revises noise provisions to move duties of the public health administrator to the director of the department of permitting and environmental review, eliminates requirements related to gency measurement of decibel levels, clarifies and expands the definition of public disturbance noises to include any noise, including from watercraft, that unreasonably disturbs or interferes with the peace, comfort or repose of persons and modify construction noise hours and decibel limits. Vialation of the county noise code could result in an infraction with a fine of up to \$125 with the arount doubling with each subsequent offense within a twelve month period, but with apportunity for mediation.
