My work includes budget and tax transparency and reform, environmental challenges, public education from early learning and K-12 through higher education, transportation, marijuana regulation, eliminating the death penalty, government ethics, reforming government spending and more. I agree with the core values, spirit and policy frameworks articulated in the platform. There are a small number of specific items that I believe may require modest qualification on financial or policy grounds.

As an elected leader, what will you do to promote increased awareness of the climate crisis, and what public policy would you endorse to reduce emissions and penalize producers of pollutants? Do you support Governor Inslee's Pollution Accountability Act, which would impose a cap and trade system?

As chair of the Finance Committee, I have been an active supporter of the Governor's environmental and fiscal approach to place a price on the externalities of carbon. I have actively partnered with major environmental organizations including Washington Conservation Voters, Sierra Club, Climate Solutions and leadership to propose and advocate for carbon pricing policies.

Describe your vision for tax reform and tax fairness. What changes to the state's tax system would you ask the Legislature to make? If you were in charge of putting together a budget proposal for your city or district, what would it look like? Would you be willing to raise revenue to avoid harmful cuts to public services?

As a lead budget writer in the House, I have worked diligently to institute a more economically efficient and equitable tax structure. This includes leading efforts to close unproductive tax preferences, ensuring transparency and public access to vital information and much more. Tax, budget and broader fiscal transparency is a central issue relative to how resources flow into and out of Olympia. There is a critical need for a more open and transparent approach to who benefits from tax preferences and the impact of the opportunity cost of those resources. Washington has the most economically inefficient and inequitable tax system in the nation, and I am inspired to work toward a more modern 21st Century structure to better serve our state's future.
