Ordinance 18282 creates the Lake Geneva Lake Management District (Lake Management District No. 2). The boundaries of the district include all lakeside parcels to Lake Geneva. The duration of the district shall be 2016 through 2026. The activities to be financed by the district shall be those described in the lake management plan adopted by Ordinance 1828. Special assessments of \$14,500 are proposed to be collected annually to finance the district activities for ten years, with the total amount to be collected during the life of the district being \$145,000. The district will be administered by King County through the Department of Natural Resources and Parks. A property owner's advisory committee will provide advice to the County, including the work program and budget.
