l	AN ORDINANCE related to superior court; providing for
2	an annual gathering and reception for superior court judges,
3	staff and volunteers and authorizing meal and refreshment
4	costs for such reception; and adding a new section to
5	K.C.C. chapter 2.69.

8	STATEMENT OF FACTS:
9	1. The mission of King County superior court is to serve the public by
10	ensuring justice through accessible and effective forums for the fair, just
11	understandable and timely resolution of legal matters.
12	2. In fulfilling its mission, the superior court receives the benefit of
13	thousands of hours of volunteer services through programs such as
14	Dependency Court Appointed Special Advocate, Partnership for Youth
15	Justice and Guardianship/Probate.

16	3. Volunteers in these and other court-sponsored programs provide
17	incalculable public benefits, assisting youth, families and others as they
18	interact with the legal system.
19	4. Because they serve as volunteers, court volunteers are ineligible for
20	expense reimbursement, and any costs incurred in the performance of their
21	duties are their own responsibility.
22	5. It is in the county's interest to provide for interaction between King
23	County superior court judges, staff and volunteers to promote
24	communication and the transfer of information that will inform court
25	activities.
26	6. Therefore, it is appropriate for superior court to hold an annual
27	gathering and reception in order to provide King County's elected judges
28	and court staff with an opportunity to interact with court volunteers in a
29	setting that will provide an open forum for discussion, as well as an
30	opportunity for the county to express its appreciation for their service.
31	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
32	NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 2.69 a
33	new section to read as follows:
34	Annual gathering and reception for superior court volunteers.
35	A. The presiding judge of the superior court may annually convene a gathering
36	and reception between superior court judges, staff and volunteers. The intent of
37	convening the gathering and reception shall be to:
38	1. Increase communication between superior court judges, staff and volunteers;

39	2. Provide for informal discussion between superior court judges, staff and
40	volunteers; and
41	3. Foster a spirit of cooperation in serving the public.
42	B. Costs of meals or refreshments for superior court judges, staff and volunteers
43	attending the meeting and reception are hereby authorized, subject to the availability of
