111	((1998)) 2004, together with amendments, additions, and deletions ((hereinafter)) adopted
112	in this chapter by reference, together with King County modifications are adopted as the
113	Fire Code of King County, and ((hereinafter)) referred to in this chapter as "this code."
114	Administrative rules may be adopted in accordance with K.C.C. chapter 2.98 to further
115	clarify and implement these code requirements. The King County modifications shall be
116	codified in this chapter.

139	1. Procedures to assure that building permits for structures shall conform to the
140	requirements of this code.
141	2. Procedures to assure that applicable standards of this code shall be reviewed as
142	part of the subdivision, short subdivision, urban planned development, rezone,
143	conditional use, special use, site development permit, binding site plan and building
144	permit processes.

146	known as NFPA 13R shall be applied as a minimum standard to all R((1)) occupancies.
147	4. Procedures to allow for relaxation of the hydrant spacing requirements by as

151	such rules and regulations shall be filed with the clerk of the council and shall be in effect

239	authority to consider deviations from the standards established for life safety/rescue
240	access, fire detection systems and fire sprinkler systems.
241	1. If the Fire Marshal finds that the deviation would not unreasonably reduce fire
242	protection to the area or structures served, and determines that the deviation should be
243	approved, the Fire Marshal shall notify the fire chief of the applicable fire district of the

244	deviation request. The Fire Marshal may approve the deviation if the fire chief of the
245	applicable fire district either concurs in writing with the Fire Marshal or does not respond
· 246	in writing within seven working days after notification of the deviation request. The fire

286	requires approval of the Fire Marshal, is started or proceeded with prior to obtaining said
287	approval, the ordinary fees specified in K.C.C. Title 27 shall be doubled. The payment of

such double fee shall not relieve any persons from fully complying with the requirement
of this code in the execution of the work nor from any other penalties prescribed herein.

To determine and decide the suitability of alternate materials and methods of construction and to provide reasonable interpretations of the provisions of the code there shall be and hereby is created a fire code board of appeals. The board shall consist of ((nine (9))) five members who are qualified by experience and training to pass judgment upon pertinent matters. The Fire Marshal shall be an ex officio member and he/she or a designated appointee shall act as secretary of the board. The fire code appeals board shall be appointed by the executive, confirmed by the council, and shall serve for not more than two four-year terms or until their successor is appointed and qualified. The board shall adopt reasonable rules and regulations for conducting its investigations and shall render decisions and findings in writing to the Local Fire District Chief, with a duplicate copy to the appellant, which shall be advisory unless otherwise specified in this ((C))code. 322	23 by notice in writing served on any persons engaged in the doing or causing such work
323	to be done, or by posting such notice in a conspicuous place on the premises where the
324	violation is occurring, and any such persons shall forthwith stop such work until
325	authorized by the fire marshal to proceed with the work.
326	Whenever any work is being done contrary to the provisions of this code, the fire
327	marshal may order the violations corrected without ordering all work stopped by issuing
328	a correction notice which identifies the violation. The correction notice may require
329	reinspection prior to further constructions or at the time of the next required inspection.
330	The correction notice shall be served or posted in the same manner as a stop work order.

1090	B. The department ((of planning and community development)) shall adopt rules
1091	and regulations specifying the number and location of fire hydrants for structures and uses
1092	which require more than one fire hydrant.
1093	SECTION 121. Ordinance 5828, Section 8, and K.C.C. 17.08.070 are each hereby
1094	amended to read as follows:
1095	Minimum water flow requirements.
1096	A. The department ((of planning and community development)) shall adopt rules
1097	and regulations based upon the Guide for Determination of Required Fire Flow, 1974
1098	Edition, published by the Insurance Service Office, establishing criteria for determination
1099	of water flow requirements sufficient to provide reasonable fire protection.
1100	B. In no event, shall the water flow required for any use be less than that required
1101	by ((WAC C))chapters 248-54 and 248-57 <u>WAC</u> .
1102	SECTION 122. Ordinance 5828, Section 9, and K.C.C. 17.08.080 are each hereby
1103	amended to read as follows:
1104	Fire hydrants. The department ((of planning and community development)) shall
1105	adopt rules and regulations establishing standards for design and installation of fire
1106	hydrants as necessary to meet sound engineering practices and provide reasonable fire
1107	protection.

1108	SECTION 123. Ordinance 5828, Section 10, as amended, and K.C.C. 17.08.090
1109	are each hereby amended to read as follows:
1110	Variances.
1111	A. The fire marshal shall have the authority to approve deviations from the
1112	standards established ((pursuant to)) under this chapter when it is shown that:
1113	1. ((s))Strict compliance would require unreasonable fire hydrant locations, fire
1114	flow requirements or water main sizes; and
1115	2. $((t))$ The variance would not unreasonably affect adequate fire protection to the
1116	area or structures served.
1117	B. The fire marshal ((shall)) may approve variances, except as provided in
1118	subsection C. of this section for connections to single family residences served by existing
1119	water system ((which)) that have fire hydrants and fire flow of at least ((500)) five hundred
1120	gallons per minute if the variance would not unreasonably affect fire protection and
1121	((provided that)) only if the purveyor's approved comprehensive plan includes a method fo
1122	increasing fire flow to current standards.
1123	C. The fire marshal shall not approve any variance which would result in a
1124	violation of ((WACC))chapters 248-54 and 248-57 WAC without prior approval of the
1125	state Department of Social and Health Services.
1126	SECTION 124. Ordinance 5828, Section 11, and K.C.C. 17.08.130 are each
1127	hereby amended to read as follows:
1128	Water ((P))purveyor ((A))authority. Nothing in this chapter or rules and
1129	regulations adopted by the department ((of planning and community development pursuant
1130	to)) in accordance with this chapter shall be construed to prohibit water purveyors from

1131	imposing more stringent requirements for the construction of water mains and fire
1132	hydrants.
1133	SECTION 125. Ordinance 5828, Section 12, and K.C.C. 17.08.140 are each
1134	hereby amended to read as follows:
1135	Individual service connections. No more than ((60)) sixty feet of piping ((which))
1136	that connects the customer's plumbing system to the purveyor's water main or water meter
1137	shall be located in any public road right-of-way unless approved ((pursuant to)) in
1138	accordance with K.C.C. chapter 14.28.
1139	SECTION 126. Severability. If any provision of this ordinance or its application
1140	to any person or circumstance is held invalid the remainder of the ordinance or the

1141 application of the provision to other persons or circumstances is not affected. 1142 SECTION 127. Effective date.
