1	AN ORDINANCE relating to the annexation of an area
2	known as Easterly-Weiss Annexation to King County
3	Water District No. 119 for the purpose of providing water
4	service.

7	STATEMENT OF FACTS:
8	1. A notice of intention proposing the annexation of an area known as
9	Easterly-Weiss for water service was filed with the county council on May
10	23, 2002.
11	2. King County water district no. 119 has passed a resolution annexing
12	certain property by the resolution method of RCW 57.24.170 in
13	Resolution No. 403.
14	3. King County water district no. 119 issued a determination of
15	nonsignificance on the proposed annexation dated April 3, 2002.
16	4. The utilities technical review committee recommended county council
17	approval of the proposed annexation on July 12, 2002.

18	5. The county council held a public hearing on July 8, 2002, and has
19	considered the criteria set forth in RCW 57.02.040(3).
20	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
21	SECTION 1. Findings. The county council finds that:
22	A. The proposed action is in compliance with the county's Comprehensive Plan;
23	B. The proposed action is in compliance with the policies expressed in the
24	district's plan for water or sewage facilities, or both.
25	SECTION 2. After consideration of the criteria listed in RCW 57.02.040(3), the
26	annexation by King County water district no. 119 of the area known as the Easterly-
27	Weiss Annexation and described in Attachment A to this ordinance is consistent with
28	those criteria and is approved. Pursuant to RCW 57.02.045, this approval is final unless
29	review is taken by the King County boundary review board under chapter 36.93 RCW.
30	SECTION 3. King County water district no. 119 is the appropriate entity to serve
31	the area proposed to be annexed.
32	SECTION 4. Completion of this annexation does not constitute county approval

or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.


A. Legal Description for Easterly-Weiss Annexation Area, B. Vicinity Map, C. Annexation Boundary Map


