Findings:** A. Due to the increasing and persistent nature of homelessness in King County 6 and elsewhere in the nation, on November 2, 2015, the King County executive declared a 7 8 homeless state of emergency. Every day large numbers of individuals and families in our community go unsheltered. At this time our community simply does not have the 9 10 capacity to meet the need. B. On January 28, 2016, more than four thousand five hundred five individuals 11 were living outside and another six thousand one hundred eighty-three individuals were 12 13 in shelters or transitional housing in King County, according to the One Night Count 14 conducted by All Home. C. All Home adopted a new strategic plan on June 30, 2015. The plan found that 15 16 emergency shelters are a critical component to our regional homeless crisis response. In 2014, data shows that nine thousand four hundred eighty-two households utilized shelter 17 and transitional housing in King County, and of these, approximately fifty percent were 18 19 newly homeless. The plan calls for ensuring sufficient shelter capacity, including non-

- traditional shelter models that provide pathways to housing and interventions for longterm shelter stayers.
- D. King County has recognized a need for emergency shelter during the winter months and has provided winter shelter for more than twenty years.

- E. Due to increasing prevalence of homelessness, the declaration of a homeless emergency, and the decreased shelter capacity in the city of Seattle, King County added fifty beds of shelter services in the County-owned 420 Fourth Avenue Building and extended shelter services at the King County Administration Building to one hundred beds.
- F. The King County council acknowledges continued operations of the emergency shelters beyond their traditional closing date of April 15 as follows. The fifty shelter beds in the King County Administration Building are to operate from 7:00 p.m. to 6:00 a.m. through December 31, 2016. The other fifty shelter beds operated in the King County Administration Building lobby from 7:00 p.m. to 6:00 a.m. through September 15, 2016. The fifty shelter beds in the 420 Fourth Avenue Building are to operate from 7:00 p.m. to 6:00 a.m. through October 31, 2016, or until a new shelter at a county-owned property can be opened. King County will work to open up to seventy shelter beds in a county-owned property by November 1, 2016, or as soon after that as possible, with operations continuing through the end of 2016.
- 39 G. The estimated additional management, utilities and security cost to extend the 40 size and hours of the emergency shelters, as described in subsection F. of this section, for 41 the period from April 16, 2016, through December 31, 2016, is \$755,000.

204	increase the operating hours of the Salvation Army - Men's Homeless Winter Shelter in
205	order to provide one hundred beds and eleven shelter hours per night, from 7:00 p.m. to
206	6:00 a.m., from February 1, 2015, through April 15, 2015.
207	ER4 EXPENDITURE RESTRICTION:
208	Of this appropriation, in 2016, \$100,000 shall be expended solely to administer a
209	competitive grant program to support mentorship services for youth. The department
210	shall issue a request for proposals, evaluate proposals and award funds based on criteria
211	defined in Motion 14489.
212	ER5 EXPENDITURE RESTRICTION:
213	Of this appropriation, \$276,000 shall be expended solely to contract for case
214	managers, outreach workers and support staff to provide comprehensive advocacy to
215	youth and their families throughout their contact with the juvenile justice system. This
216	appropriation is intended to fund four case managers, four outreach workers, and one
217	support staff for approximately six months.
218	ER6 EXPENDITURE RESTRICTION:
219	Of this appropriation, \$2,500 shall be transferred solely to the parks and
220	recreation appropriation unit.
221	ER7 EXPENDITURE RESTRICTION:

241	Of this appropriation, \$50,000 shall not be expended or encumbered until the
242	executive transmits a report on the King County men's winter shelter and a motion that
243	approves the report and the motion is passed by the council. The motion shall reference
244	the subject matter, the proviso's ordinance, ordinance section and proviso number in both
245	the title and body of the motion.
246	The report shall provide an update on the status of the King County men's winter
247	shelter and plans for winter 2015-2016. The report shall include, but not be limited to:

248	A. A summary of usage of the King County men's winter shelter for winter 201
249	2015, with the average number of those accommodated and turned away by week;
250	B. An analysis of potential alternative locations for a men's winter shelter that
251	could accommodate between fifty and one hundred single adult men who are
252	experiencing homelessness. The analysis should compare the winter shelter's current
253	location in the King County administration building with other potential locations in or
254	near the downtown Seattle area. The analysis of potential locations should include for
255	each potential location:
256	1. Bed capacity;
257	2. Location for men to queue while awaiting the shelter's opening each night,
258	noting potential locations that could offer a covered waiting area;
259	3. Hours of availability each night;
260	4. Months of availability each winter;
261	5. Ability to store mats, bedding and other shelter supplies;
262	6. Ability to launder bedding and shelter supplies; and
263	7. Estimated cost for rent, security, utilities and other site-related expenses
264	based on an analysis of fifty beds and one hundred beds for:
265	a.(1) eight hours per night;
266	(2) nine and one-half hours per night; and
267	(3) eleven hours per night; and
268	b.(1) six and one-half months of service, for October 15 through April 30;
269	(2) seven and one-half months of service, for October 15 through May 31;
270	(3) nine months of service, for October 1 through June 30; and

271	(4) a full year of service; and
272	C. A description of potential opportunities for coordination with the city of
273	Seattle to secure a new shelter location, to expand an existing shelter location or to
274	provide services that would replace the need for emergency shelter.
275	The executive must file the report and motion required by this proviso by June 30,
276	2015, in the form of a paper original and an electronic copy with the clerk of the council,
277	who shall retain the original and provide an electronic copy to all councilmembers, the
278	council chief of staff, the policy staff director and the lead staff for the law, justice, health
279	and human services committee, or its successor.

292	and dates of the Salvation Army - Men's Homeless Winter Shelter in order to provide:
293	fifty beds in the King County Administration Building from June 1, 2016, through

December 31, 2016; fifty beds in the 420 Fourth Avenue Building from June 1, 2016, 294 through October 31, 2016; and fifty beds in the King County Administration Building 295 lobby from June 1, 2016, through September 15, 2016. Additionally, of this 296 appropriation, \$9,124 shall be spent either for ongoing operations of an emergency 297 homeless shelter in the 420 Fourth Avenue Building or for the operation of an emergency 298 homeless shelter in a yet to be determined King County property from November 1, 299 300 2016, through December 31, 2016. 301 P1 PROVIDED THAT: Of this appropriation, \$720,000 shall not be expended or encumbered until the 302 executive transmits a scoping report on the county's future operational and space needs in 303 the downtown Seattle campus as a whole and updates the Real Property Asset 304 Management Plan as mandated by K.C.C. 20.12.100 and a motion that approves the 305 report and the motion is passed by the council. The motion shall reference the subject 306 307 matter, the ordinance number, the ordinance section number and the proviso number in 308 both the title and body of the motion. The scoping report shall include, but not be limited to: 309 A. A plan for identification of the tenants' future operational and space needs 310 within King County's downtown Seattle civic campus through 2025, including, but not 311 limited to, total useable square feet, a list of current King County operations, staffing and 312 space utilized at each location, current unoccupied, useable square feet at each location, 313 and potential funding alternatives, including public/private partnerships. The civic 314 campus shall include, but is not limited to, the following properties and the tenants 315

327	and oversight committee, or its successor."
328	EFFECT: The amendment would correct several technical errors (typographical
329	and drafting errors). It would allow for flexibility in the opening date of the new,
330	still-to-be-determined shelter space and provide for ongoing operations at the 420
331	Fourth Avenue shelter until the new shelter space can be opened. It would add
332	\$20,000 in appropriation authority to the Executive's transmittal, for a total cost of
333	\$755,000 (\$455,000 from the General Fund and \$300,000 from the City of Seattle) to
334	reflect the fact that the Administration Building Lobby shelter remained open until
