A. GENERAL INFORMATION

B. HISTORY

R.C.W. 36.87 establishes the right of property owners to petition a county legislative body for the vacation of road rights-of-way. K.C.C. 14.40 establishes King County policies and procedures for accomplishing same.

The petition was filed on July 15, 2016 with the Clerk of the King County Council. The Department of Transportation, Road Services Division (Roads) circulated the request for vacation, soliciting comments from the agencies listed below. The petition requested vacation of portions of 13th Avenue SW between Blocks 31 and 32 lying south of SW 102nd Street and North of 104th Street and 14th Avenue SW Between Blocks 30 and 31 lying south of SW 102nd Street and North of SW

104th Street, per Plat of State Addition to the City of Seattle Number 5 located in the NW quarter of Section 6, Township 23 N, Range 4 E, W.M. and Thomas Brothers Page 624. Said right-of-way is located within Steve Cox Memorial Park in the White Center area of King County.

A search of records by staff found that King County acquired the subject right-of-way by dedication with the recording of the Plat of State Addition to the City of Seattle Number 5, recorded in volume 17 of plats, page 79, records of King County Washington dated April 14, 1909.

No public funds were expended in the acquisition of this right-of-way. The subject portion of the right-of-way is fully within the King County Steve Cox Memorial Park. No history of use or improvement of the subject right-of-way for road purposes has been located.

King County Department of Natural Resources and Parks, Parks and Recreation Division (Parks) describes Steve Cox Memorial Park on its website as follows:

Formerly White Center Park, this park was renamed Steve Cox Memorial Park in 2007 in honor of a fallen King County Sheriff's Deputy who was also a beloved community leader. The park offers Mel Olson Stadium, baseball fields, basketball courts, tennis courts, play and picnic areas, and a foot reflexology walking path. This park is also home to the White Center Community Center, an historical building constructed as a Works Progress Administration project in 1940.

Also known as the "Log Cabin", the community center houses King County Parks' White Center Teen Program, which provides after-school recreational programming to neighborhood youth aged 12 to 19.

In 2008, major renovations upgraded the baseball stadium with a synthetic turf infield and other improvements as part of King County Park's CPG program.

C. NOTICE

Notice of this hearing was posted at the termini of the proposed vacation area on August 31, 2017 and published in accordance with requirements of RCW 36.87.060. The Affidavit of Posting is included as Exhibit #15.

D. REVIEWING AGENCIES AND COMMENTS

Roads did not receive responses from Frontier Communication or the following King County agencies: Department of Executive Services, Real Estate Services Division; and the Department of Natural Resources and Parks, Open Space and Water and Land Divisions. A copy of the Final Notice is included as Exhibit #8.

E. OTHER COMMENTS: None.

F. COUNTY ROAD ENGINEER RECOMMENDATION

The Department of Transportation recommends vacating the right-of-way. The subject right-ofway is useless to the County Road System. The full report of the County Road Engineer is included as Exhibit #11.

G. COMPENSATION

Given the intended full incorporation of the right-of-way into King County Steve Cox Memorial Park, the public benefit associated with the continued maintenance and utilization of the right-of-way as part of the park, and the release of Roads from obligations and liability risk associated with this section of useless right-of-way, the County Road Engineer recommends that under KCC 14.40.020(B), the right-of-way be vacated for no monetary compensation.

Road vacations are a unique activity created and governed specifically by statute and county code. The circumstances, methodology and purpose of road vacations are limited to the statutes and codes from which they arise. While the law applicable to other government activities may be intriguing, it is not applicable. RCW 36.87 and King County Code section 14.40 govern this action.

Under KCC 14.40.020, compensation may be required as a condition of a road vacation. The requirement is discretionary, not mandatory. If the county council chooses to require compensation for a road vacation, it "may consider as a factor the assessed land value of the parcels adjacent to the county right of way proposed for vacation in addition to the factors listed in RCW 36.87.120."

The particular vacation area in this petitioner is surrounded by a King County Park. As a government owned property, the park does not receive an assessed value. While the property surrounding the subject right-of-way is currently a King County Park, it is zoned CB for Community Business. Other properties in the general area with similar zoning are improved with retail, fast food and service businesses and have averaged assessed land value of \$22.71 per square foot.

The total vacation area is 72,211.45 square feet. Application of the averaged assessed value of \$22.71 per square foot to the 72,211.45 square feet results in a total of \$1,639,922.03.

The assessed land value of the adjacent parcels may be considered as a factor in the calculation of compensation. However, for the many reasons listed below, the average assessed land value of

improved properties with the Community Business zoning around Steve Cox Memorial Park is not directly comparable to the value of the vacation. At a minimum, there is no reason to expect that King County will discontinue the use of the park property as a public park and convert the use to a retail or fast food business.

Furthermore, unlike tax title parcels or other property owned by the county, sections of right-of-way do not have a readily open market. Vacation pursuant to RCW 36.87, 58.17 and KCC 14.40 is the only method to eliminate the county's interest in useless county right-of-way and the only method by which the county may divest itself of the duty and liability of maintaining county roads. *See Attorney General Opinion 57-58 No.3, March 13, 1957*. Upon vacation, the right-of-way interest is eliminated and the full rights to the underlying property revert to their historical origin. In most instances, the vacated area attaches to the abutting property. When the right-of-way is created by plat, the interests in the right-of-way revert to the adjoining parcels within the plat upon vacation. Except in the very limited circumstance of vacating right-of-way to anyone other than the abutting property. Therefore, the area to be vacated does not have a ready market for its sale. The only party that can acquire the vacated area from the county is the abutting property owner. The county cannot sell the vacation area on an open market.

Unlike the improved parcels around Steve Cox Memorial Park used to calculate the average assessed land value, the vacation area cannot be sold or transferred to third parties on an open market. The lack of a true market for the vacation area differentiates the vacation area from the properties used to calculate the average assessed land values.

Utilizing the additional factors provided in RCW 36.87.120, the possible compensation amount is further adjusted to reflect the value of the transfer of liability or risk, the avoided costs for management or maintenance and future public benefit.

RCW 36.87.120 allows the County to adjust the appraised value of proposed vacation area "to reflect the value of the transfer of liability or risk, the increased value to the public in property taxes, the avoided costs for management or maintenance, and any limits on development or future public benefit."

The following facts were considered in reaching the recommendation that monetary compensation not be required as a condition for the vacation of the subject right-of-way.

- The right-of-way was acquired by plat without payment of public funds;
- The right-of-way is occupied by ball fields and buildings of Steve Cox Memorial Park;
- As part of a public park and unable to be sold on an open market, the right-of-way is not directly comparable to the other similarly zoned properties in the area;
- Upon vacation, Roads is relieved of the duty and liability of maintaining this portion of county right-of-way;

- Upon vacation, Roads is relieved of the duty and liability of enforcement, monitoring and management of the right-of-way;
- Upon vacation Roads is relieved of liability that can arise as an owner of right-of-way being by the public for non-road purposes;
- Retention of the right-of-way as right-of-way serves no public purpose; and
- Once vacated and fully incorporated into the park, King County DNRP, the county exposure to risk and liability is reduced due to the limitations on liability associated with properties open for recreational use under Washington's recreational use statute, RCW 4.24.200-210.

Roads maintains approximately 1500 miles of roadway within unincorporated King County. Roads staff respond to complaints regarding the use of opened and unopened right-of-way including; damage to personal property from trees within the right-of-way; illegal placement of obstructions, gates, fences and rockeries; structures and other construction within the right-of-way; dumping; and abandonment of junk vehicles. Every maintenance or improvement activity, enforcement action or investigation that Roads must respond to, regardless of whether it involves opened or unopened, improved or unimproved right-of-way, is an opportunity cost and loss to Roads.

Roads has limited staff hours available to maintain and improve the county road system. Diverting Roads staff to respond to calls associated with unopened right-of-way is a direct loss to the county and the public. In such instances, Roads staff would not be addressing critical daily work on the County's contiguous road system.

Roads receives a dedicated fund for road purposes such as the maintenance of improved county roads. Road fund dollars should not be spend for enforcement, management or clean-up of unopened unimproved right-of-way or the payment of claims. Vacation of useless right-of-way and reduction of the obligations associated with such right-of-way directly benefits the County and its citizens.

In addition to the reduction or elimination of opportunity costs associated with diverting Roads staff from critical daily work on the contiguous road system, the vacation of this right-of-way reduces Roads liability and risk exposure. Roads is at risk of a liability claim arising out of the use of every segment, every mile, every yard and every foot of open and unopened right-of-way. Vacation of this right-of-way reduces Roads exposure to a liability claim.

King County Office of Risk Management Services reports that as of March 2017 it had closed 428 claims on behalf of Roads for the five year period of January 1, 2012 through December 31, 2016. Of the 428 claims closed, 152 (64%) were closed with payments. In 2016, the Office of Risk Management Services paid \$3,022,232 to resolve 21 claims on behalf of Roads. Of the claims closed in 2016, 99% of the funds expended were spent on claims arising from just two incidents. As of December 31, 2016, 42 claims against Roads remained open with Risk. For the remaining 42 claims, Risk had expended \$1.5 million in expenses and had an addition \$4 million set for reserves.

Roads seeks to reduce potential liability and benefit the citizens of King County through the vacation of this right-of-way and full and complete incorporation of the subject property in to the Steve Cox Memorial Park. The cost of just one claim can far surpass the straight calculated compensation for the vacation of this right-of-way.

Risk is challenging to quantify. Unlike regular and predictable expenditures, risk is a future state. The best one can do to attempt to analyze or predict risk is to look at historical claims. However, we can predict that by vacating this right-of-way to Parks the County and its citizens will benefit from a reduction in potential liability and risk. As mentioned above, Parks is the beneficiary of limitations on liability under Washington's recreational use statute, RCW 4.24.200-210. Roads does not enjoy such benefit. Upon transfer of this right-of-way from Roads to Parks, the county greatly reduces its risk and liability exposure and the citizens retain a beneficial community asset.

Roads seeks to reduce potential obligations, opportunity costs, and liability risk while benefiting the citizens of King County through the vacation of this portion of right-of-way. The dollars Roads might obtain from the petitioner through the vacation of this portion of right-of-way is insignificant in comparison to the County's potential liability from its mere retention as right-of-way. These sections of unopened right-of-way are particularly concerning. Not only are they open to the public, but the public is actively invited and encouraged to use the right-of-way in a manner inconsistent with right-of-way use.

Steve Cox Park provides its community with play fields, meeting rooms, tennis courts, ball fields, playground equipment, parking lots and office areas. Right-of-way is not designed or intended for use as part of a baseball field, a tennis court or a climbing structure. Right-of-way is not intended to support a building or parking lot. All aspects of the use of this right-of-way within Steve Cox Park is inconsistent with its designation as right-of-way. The reduction of risk and the costs associated with such risk is the greatest benefit the public can receive from a road vacation.

However, an additional public benefit obtained through the vacation of this useless right-of-way, is the elimination of conflicting government functions. The county and its citizens benefit from the elimination of Roads property interests and its obligations and duties to maintain such property interests within a park. If Parks is managing the park, yet Roads must maintain and manage its right-of-way, the potential, if not actual, conflicts from the activities and duplication of functions unduly burdens the County's resources. Additionally, the potential failure of Parks to properly maintain Roads right-of-way could besmirch Roads standing in the community.

Throughout the county there are segments of right-of-way that are useless to the county road system. The county has many unopened short useless segments of right-of-way that will never be made into a county road. However, the county has the burdens of ownership and risk, which are risks to the county with no public benefit. The retention of random property rights not useful or contributing to the county road system is contrary to the core business of Roads. Vacation is the only mechanism to move these useless segments of right-of-way out of the county inventory and relieve Roads of the duty and liability associated with this right-of-way. The subject right-of-way

is one of the useless segments of right-of-way that is better in the ownership of the Parks Division incorporated into the park than retained by Roads as right-of-way.

The public will benefit from the vacation of the right-of-way. Vacation will allow the right-of-way to be fully and completely incorporated into the Steve Cox Memorial Park. Upon vacation and full incorporation into the park, the Department of Transportation Road Services Division will no longer be responsible for any maintenance, upkeep, improvement or liability associated with this right-of-way. Vacation of this right-of-way would fully transfer to Parks the custodianship and responsibility for the property and its care.

Therefore, the County Road Engineer recommends that the subject right-of-way be vacated and the county accept the non-monetary benefits outlined above as sufficient compensation for the approval of this road vacation.
