Manage Supply

- Implement carpool permit parking
- Increase enforcement
- Phased regional approach

Build New Supply


- Expansion planning



Carpool Permit Parking

Pilot Status

- Free HOV parking permits
- Began Feb 2017 at 6 lots
- Expanded Nov 2017 to 15 lots
- 137 active permits
- Customers ranked “certainty of finding a space” as most important benefit
- One year pilot evaluation under way



Increase Enforcement


Problem

- Some P&R's experience high rates of parking violations

Solution

- Enhanced enforcement:
 - Launched effort in Spring 2017
 - 4 high, 11 medium-priority lots
 - 444 warnings at priority lots

Violation Notices Issued
Since June by Lot Type



Leased Lot Expansion

Funding for 400 stalls

- Factors for site selection:
 - Service Availability
 - Site Conditions
 - Land use / Lease Terms
- Market study complete
- Recruitment letters sent to owners
- City permitting processes under way



Park & Ride Partnership

Launched May 2017

- 14 sites, 230 stalls, 52 active permits
- Prices range from \$32-173/month
- Partnership with Diamond Parking
- Funded by FHWA grant


Parking Expansion Planning

Study under way to develop:

- Bicycle parking guidelines and prioritized list of sites for expansion
- Process and criteria for evaluating vehicle parking locations and partnership opportunities in the future
- Evaluation criteria include:
 - Transit access to key destinations
 - Potential demand
 - ESJ access
 - Reasonable Zone 3 and 4 access
 - TOD potential
 - No major ST investments planned
 - Leverages Metro investments



Regional Approach to Parking Management



SOV Parking Permit Program Design

Program elements could include:

- Portion of stalls for permit parking only M-F during the AM rush hour
- SOV permits available at very full lots that are owned by Metro
- Regular transit ridership required for monthly permit renewals
- Monthly fee for SOV permits; discounted fee for ORCA LIFT-eligible customers



SOV Parking Permit Outreach Approach

Metro/ST coordinated outreach Feb– Mar:

- Web and print survey available mid-Feb through Mar
- 7 drop-in session/open houses (5 in King County, 1 in Pierce, 1 in Snohomish)
- Street teams at 24 park & rides
- Briefings/info-sessions with targeted ESJ stakeholders (piggybacking on King County's fare outreach process)
- Stakeholder briefings upon request
