

## PRELIMINARY REPORT:

On January 26, 2018, the Department of Natural Resources and Parks (DNRP) submitted its report on file no. E17CT031 to the Examiner.

## PUBLIC HEARING:

After reviewing the preliminary report and examining available information on file with the application, the Examiner conducted a public hearing on the application on February 8, 2018, in the Fred Conference Room, 12th Floor, King County Courthouse, 516 Third Avenue, Seattle, Washington.

Participants at the public hearing and the exhibits offered and entered are listed in the attached minutes. A verbatim recording of the hearing is available in the Hearing Examiner's Office.

## FINDINGS AND CONCLUSIONS:

## 1. General Information:

2. The Applicants timely filed an application to King County for PBRs program current use valuation of the property to begin in 2019. As required by law, notification of the application occurred.
3. A summary of relevant PBRs categories follows below. (Plain text represents a category an applicant requested an award for and that DNRP agrees is warranted. Any ~~strikethrough~~ represents a category an applicant requested an award for but that DNRP disagrees is warranted. Any *italics* represents a category an applicant did not request an award for, but that DNRP nonetheless concludes is warranted. And any \*asterisk\* represents a category where DNRP finds an award is warranted, but only if certain contingencies or conditions are met.)

The DNRP-recommended score of 18 points results in a current use valuation of 30% of assessed value for the enrolled portion of the property. Additional credit may be awarded administratively under the forest stewardship land and limited public access because of resource sensitivity categories.

Award of the forest stewardship land category is subject to submittal of a forest stewardship plan by **August 1, 2018**, and subsequent approval by **October 1, 2018**. Award of credit for this category will increase the point total by 5 points and may allow approved forestry activities to occur on the property.

Award of the limited public access because of resource sensitivity category is subject to submittal, by **October 1, 2018**, of documentation DNRP deems acceptable to establish sufficient use by the general public. Award of credit for this category will increase the point total by 5 points.

Award of either or both of these categories will result in a current use valuation of 20%.

4. As to the land area recommended for PBRs enrollment, the Applicant requested 6.78 acres and DNRP recommends 6.78 acres. (Enrollment acreage is the entire parcel less the excluded area, as calculated by DNRP. In the event the County Assessor's official parcel size is revised, the PBRs acreage shall be administratively adjusted to reflect that change.)
5. Except as modified herein, the facts set forth in DNRP's preliminary report and testimony at the February 8, 2018, public hearing are correct and incorporated herein by reference. Copies of this report and DNRP's report will be provided to the Metropolitan King County Council for final approval.
6. Approval, pursuant to the Public Benefit Rating System adopted by Chapter 20.36 KCC, of 18 points and a current use valuation of 30% of assessed value for 6.78 acres of the property, along with conditional approval of 10 additional points (which will bring the total to 28 points and 20% of assessed value for 6.78 acres of the property), is consistent with the purposes and intent of King County to maintain, preserve, conserve, and

otherwise continue in existence adequate open space lands and to assure the use and enjoyment of natural resources and scenic beauty for the economic and social well-being of King County and its citizens.

7. The subject property is currently enrolled in the Timber Land program. Any open space taxation participation agreement signed as a result of approval of this application should be worded to supersede any prior agreements for the parcel.

RECOMMENDATION:

1. APPROVE current use valuation of 30% of assessed value for the 6.78-acre enrolled portion of the property.
2. CONDITIONALLY APPROVE additional credit for the forest stewardship land and limited public access categories.

Award of the forest stewardship land category is subject to submittal of a forest stewardship plan by **August 1, 2018**, and subsequent approval by **October 1, 2018**. Award of credit for this category will increase the point total by 5 points and may allow approved forestry activities to occur on the property.

Award of the limited public access category is subject to submittal, by **October 1, 2018**, of documentation DNRP deems acceptable to establish sufficient use by the general public. Award of credit for this category will increase the point total by 5 points.

Award of either or both of these categories will result in a current use valuation of 20%.

**NOTICE OF RIGHT TO APPEAL**

A person appeals an Examiner recommendation by following the steps described in KCC 20.22.230, including filing with the Clerk of the Council a sufficient appeal statement and a \$250 appeal fee (check payable to the King County FBOD). Appeal statements may refer only to facts contained in the hearing record; new facts may not be presented on appeal. KCC 20.22.230 also requires that the appellant provide copies of the appeal statement to the Examiner and to any named parties listed on the front page of the Examiner's recommendation.

Prior to the close of business (4:30 p.m.) on *March 12, 2018*, an electronic copy of the appeal statement must be sent to [Clerk.Council@kingcounty.gov](mailto:Clerk.Council@kingcounty.gov) and a paper copy of the appeal statement must be delivered to the Clerk of the Council's Office, Room 1200, King County Courthouse, 516 Third Avenue, Seattle, Washington 98104. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. If the Office of the Clerk is not officially open on the specified closing date, delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

Unless both a timely and sufficient appeal statement and filing fee are filed by *March 12, 2018*, the Clerk of the Council shall place on the agenda of the next available Council meeting a proposed ordinance implementing the Examiner's recommended action. At that meeting the Council may adopt the Examiner's recommendation, defer action, refer the matter to a Council committee, or remand to the Examiner for further hearing or further consideration.

If a timely and sufficient appeal statement and filing fee are filed by *March 12, 2018*, the Examiner will notify all parties and interested persons and provide information about "next steps."
