NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, February 26, 2018, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2018-0064 (Ordinance 18659) an ordinance relating to the County's sign code.

SUMMARY:

Ordinance 18659 amends the King County Zoning Code to allow gateway signs in unincorporated areas under certain circumstances, and to authorize a gateway sign in the unincorporated area of Preston, subject to specific design requirements.
