NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing in the Council Chambers on the 10th Floor of the King County Courthouse (516 Third Avenue, Seattle, WA) on Monday, May 7, 2018, beginning at 1:30 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2018-0148 (Ordinance 18728) an ordinance relating to the County's business licenses and regulations.

### SUMMARY:

Ordinance 18728 amends the King County Code Title 6, regarding business licenses and regulations, to replace gendered pronouns and historically gendered terms with gender neutral terms.
