Guidelines and recommendations are advisory only, and do not have the force and effect of law.

A public hearing on the proposed guidelines and recommendations at which the public may state their views orally or in writing will be held during the regular meeting of the King County Board of Health, June 21, 2018 in the Metropolitan King County Council Chambers, 10th floor, Courthouse, 516 Third Avenue, Seattle, WA.
