#### SUMMARY

Zone District ("the District") is a quasi-municipal corporation flood water and to acquire property interests by condemnation. Resolution FCD2016-20.3, adopted on November 7, 2016, and by Resolution No. FCD2017-07.2, adopted on November 13, 2017, the district board of supervisors approved the Lower Russell Road Levee Setback flood protection capital project and funding for project ("the Project"). which has been given identifying number 1112056.

An interlocal agreement between King County and the District authorizes King County to condemn all real property interests that are necessary to carry out a district flood protection

capital project. In order to allow the construction of the Project, King County purchased several properties in the project area, including a warehouse located at 22230 Russell Road S. in the City of Kent ("the Property"). The Project requires the warehouse on the Property to be demolished and removed. One tenant at the Property, Amana Global Company ("Amana") remains at the property by virtue of a sixty-month lease that was executed prior to the county's purchase of the Property ("the Leasehold Interest").
