1	A MOTION creating the legislative branch equity and
2	social justice team and adopting its mission statement.
3	WHEREAS, the council unanimously adopted Ordinance 16948, which is also
4	referred to as the Equity and Social Justice Ordinance, in 2010, defining equity for the
5	county and identifying determinants of equity and priorities for government in advancing
6	equity, and
7	WHEREAS, the Equity and Social Justice Ordinance emphasizes: the
8	consideration of equity and social justice impacts in all county decision-making;
9	improving fairness and opportunity in county government organizational practices; cross-
10	agency collaboration on equity and social justice efforts; and development of annual
11	agency work plans through the coordination of an interbranch equity and social justice
12	team, and
13	WHEREAS, the council annually adopts an equity and social justice work plan
14	for the legislative branch by motion, and
15	WHEREAS, the initial council work plan for equity and social justice expressed
16	commitment to increasing awareness of equity and social justice impacts of county
17	actions internally and with the public; promoting equity and fairness in the workplace;
18	and increasing opportunities for the community to engage with the council, and
19	WHEREAS, in 2012, in support of that work plan, a legislative branch equity and

20	social justice team was convened, consisting of representatives from all legislative branch
21	agencies, and
22	WHEREAS, the legislative branch equity and social justice team has continued to
23	convene regularly since 2012. However, the council desires to formalize the
24	establishment of the legislative branch equity and social justice team to ensure that equity
25	and social justice remains a high priority for the legislative branch;
26	NOW, THEREFORE, BE IT MOVED by the Council of King County:
27	A. The legislative branch equity and social justice team is hereby created.
28	B. The team shall consist of, but not be limited to, the following people:
29	1. One representative from each legislative branch independent agency and the
30	flood control district;
31	2. One district office staff appointed by each county councilmember;
32	3. One representative from central administration;
33	4. The community outreach coordinator;
34	5. The director of legislative analysis;
35	6. The council chief of staff; and
36	7. At least two representatives from central policy staff who volunteer to serve
37	on the team.
38	C. The mission of the team shall be to build awareness, increase understanding
39	and develop strategies to further equity and social justice in the legislative workplace,
40	policies and engagement with communities of color and poor and disadvantaged groups
41	residing in urban, suburban and rural King County.
42	D. The team shall elect a chair each year, who will serve a one-year term, and the

43	chair shall be responsible for facilitating team meetings, guiding the implementation of
44	the work plan, setting the agenda for each monthly meeting and any other special meeting
45	of the team and ensuring that the team is meeting the goals as laid out in the work plan.
46	E. The community outreach coordinator shall serve as the primary staff to the
47	team chair and assist the team chair in carrying out all of the chair's responsibilities as
48	outlined in this motion and any new responsibilities that may be identified by the team.
49	F. The team's scope of work shall include, but not be limited to:
50	1. Drafting a biennial legislative branch equity and social justice work plan for
51	possible adoption by council motion. The work plan shall include, but not be limited to,
52	identifying proclamation proposals for consideration and possible council adoption, and
53	identifying and coordinating learning and discussion sessions. A draft of the work plan
54	shall be completed for council adoption by January 1 of every odd year;
55	2. Facilitating the activities of the work plan;
56	3. Designating a liaison to the interbranch equity and social justice team and
57	representing the legislative branch at the interbranch equity and social justice team's
58	meetings;
59	4. Collaborating with the interbranch equity and social justice team and the
60	office of equity and social justice on broader equity and social justice activities that
61	impact the county;
62	5. Preparing an annual summary to the council that evaluates the progress of the
63	work plan; and

6. Convening at least monthly to perform the duties as required in this section F.

G. The team shall establish a safe environment to ensure that all team members

- 66 fully participate in all team activities without repercussion or concern of impacting their
- 67 primary legislative branch responsibilities.
