1 AN ORDINANCE creating new funds for the 2019-2020
2 budget, including for the water and land resources shared
3 services and for water quality internally financed projects;
4 and adding new sections to K.C.C. chapter 4A.200.

5 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

6 NEW SECTION. SECTION 1. There is hereby added to K.C.C. chapter 4A.200

7 a new section to read as follows:

8 A. There is hereby created the water and land resources shared services fund.

9 B. The fund shall be a first tier fund. It is a special revenue fund.

10 C. The director of the department of natural resources and parks shall be the
11 manager of the fund.

12 D. The fund shall be used to collect revenue from:

13 1. Internal transfers;

14 2. Federal or state grants and agreements; and

15 3. Other restricted funding sources.

16 E. Consistent with any restrictions on revenues, moneys in the fund shall only be
17 expended for providing services, coordination and technical assistance concerning water
18 and land resources for the county and other governments, including assisting in setting
19 and implementing priorities for water and land resources, sample collection, laboratory

20 services, monitoring, analysis and other activities to protect, enhance and evaluate the
21 quality of land, habitat and water resources programs, and to protect public health and the
22 environment by providing technical assistance and education to businesses and the
23 general public to encourage environmental stewardship, and related administration of the
24 water and land resources division.

25 NEW SECTION. SECTION 2. There is hereby added to K.C.C. chapter 4A.200
26 a new section to read as follows:

27 A. There is hereby created the water quality internally financed projects fund.

28 B. The fund shall be a first tier fund. It is an enterprise capital fund.

29 C. The director of the department of natural resources and parks shall be the
30 manager of the fund.


31 D. The fund shall disburse and track payments for capital projects that have a
32 non-bond source of funding.

33 E. Money from the wastewater operating fund for non-bond capital projects and
34 any other dedicated capital revenue sources shall be deposited in the fund.

County Council on 11/13/2018, by the following vote:


