The purpose of this public hearing was to consider adoption of Proposed Ordinance 2018-0310 (Ordinance 18808) an ordinance adopting findings in support of and renewing and expanding a moratorium under RCW 90.58.590 on the establishment of commercial nonnative salmon net pen aquaculture facilities.
