1	AN ORDINANCE relating to transportation network
2	companies vehicle endorsements; and amending Ordinance
3	17892, Section 26, and K.C.C. 6.64.271 and Ordinance
4	17892, Section 27, and K.C.C. 6.64.281.
5	PREAMBLE:
6	King County regulates taxis and for-hire vehicles that transport passengers
7	for compensation. The regulations are intended to ensure that customers
8	can use the options under the regulations in a safe manner.
9	Since 1979, King County, the city of Seattle and the Port of Seattle have
10	consistently worked to regionalize regulations and licensing by developing
11	consistent regulations and services across jurisdictions. The goal of the
12	cooperation is to promote public safety and customer service by
13	standardizing fees, regulations, enforcement and rate review procedures
14	throughout King County.
15	Since 2012, new transportation options that make use of application-based
16	technology on smartphones have entered the market. The new
17	organizations that use that technology as part of their business models
18	have come to be known as transportation network companies.
19	Before 2013, the new entrants had not been regulated. The city of Seattle

20	adopted regulations for transportation network companies in 2014. King
21	County adopted new regulations in September 2014, with Ordinance
22	17892, which made changes to existing regulations for transportation
23	companies and added new regulations affecting transportation network
24	company organizations, drivers and vehicles.
25	Generally, the city and the county attempt to have these regulations
26	conform so as to ensure that regulations are the same across jurisdictions.
27	However, county regulations place requirements on vehicles used by
28	drivers for transportation network companies that are different from city
29	requirements.
30	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
31	SECTION 1. Ordinance 17892, Section 26, and K.C.C. 6.64.271 are each
32	hereby amended to read as follows:
33	A. The director shall not issue a transportation network company vehicle
34	endorsement unless the person meets the following requirements:
35	1. Has a for-hire driver's ((license)) permit or transportation network company
36	license under this chapter; and
37	2. ((Is the registered owner of the vehicle; and
38	3.)) Is affiliated with a licensed transportation network company.
39	B. The director shall not issue a transportation network company vehicle
40	endorsement unless the vehicle meets the following requirements:
41	1. ((Is personal;
42	2. Is a passenger car as defined in RCW 46.04.382;

43	3.)) Has insurance that complies with K.C.C. 6.64.211 and state law; ((and
44	4.)) 2. Has a certificate of safety as required by K.C.C. 6.64.360; and
45	3. The vehicle's model year is no more than ten years old, unless otherwise
46	allowed by state law.
47	SECTION 2. Ordinance 17892, Section 27, and K.C.C. 6.64.281 are each
48	hereby amended to read as follows:
49	A. An applicant for a transportation network company vehicle endorsement, or a
50	transportation network company on behalf of the applicant, shall file annually with the
51	director a signed application on a form provided by the director to include the following
52	information about the applicant:
53	1. Name, aliases, residence ((and)) or business address and residence and
54	business telephone numbers;
55	2. ((Place and)) If the applicant is an individual, the date of birth, which shall be
56	at least twenty-one years before the date of application, height, weight, color of hair and
57	color of eyes;
58	3. If the applicant is an individual, a Washington state driver's license number.
59	The applicant shall present the applicant's Washington state driver's license or a copy at
60	the time of application;
61	4. If the applicant is an individual, $((E))$ evidence of a for-hire driver's license or
62	permit, or an approved application for a for-hire driver's license or permit;
63	5. Vehicle information including vehicle identification number or numbers and
64	Washington state license <u>plate</u> number <u>or numbers</u> ;
65	6. Evidence of vehicle insurance as required in K.C.C. 6.64.211;

66	7. Vehicle certificate of safety required by K.C.C. 6.64.360;
67	8. Whether any of the circumstances in K.C.C. 6.64.291.B. apply to the
68	applicant;
69	9. Evidence that the applicant is affiliated with a transportation network
70	company; and
71	10. Other information as reasonably determined by the director.
72	B. The transportation network company vehicle endorsement consists of a
73	certificate((, an endorsement sticker affixed to the vehicle owner's for-hire driver's
74	license,)) and an endorsement decal affixed to the vehicle. The certificate shall include
75	the following:
76	1. Vehicle identification number;
77	2. Vehicle registered owner's full legal name;
78	3. Vehicle license plate number;
79	4. Endorsement expiration date;
80	5. Unique number; and
81	6. Other information the director may reasonably require.
82	C. A transportation network company vehicle endorsement is valid for not more
83	than one year ((and shall expire the same day as the for hire driver's license it endorses))

D. A person shall not lease, transfer or assign a transportation network company vehicle endorsement.
