1 A MOTION confirming the appointment of Nanette
2 Sullivan to the citizens' elections oversight committee as
3 the representative from a nonpartisan organization active in
4 King County that evaluates candidates and ballot measures,
5 such as the Municipal League.

6 WHEREAS, the Municipal League has identified Nanette Sullivan to represent
7 the organization on the citizens' election oversight committee, and

8 WHEREAS, King County is committed to conducting open, accurate and fair
9 elections, and

10 WHEREAS, the citizens' election oversight committee help to ensure that
11 accountability and performance of the elections division is provided in a transparent
12 manner that is meaningful to King County residents, and

13 WHEREAS, fifteen of the sixteen positions on the citizens' election oversight
14 committee are currently vacant, and

15 WHEREAS, in accordance with K.C.C. 2.53.021, King County council is tasked
16 with appointing new members of the citizens' election oversight committee, and

17 WHEREAS, in accordance with K.C.C. 2.28.010, when the King County council
18 recreates a board with more than nine members, the appointed terms are staggered: one-
19 fourth for one year, one-fourth for two years, one-fourth for three years or the full term if

20 the full term is three years, and one-fourth for full terms, and

21 WHEREAS, in accordance with K.C.C. 2.53.021, the employment and
22 administration committee of the King County council appointed Nanette Sullivan on July
23 15, 2019;

24 NOW, THEREFORE, BE IT MOVED by the Council of King County:

25 The appointment of Nanette Sullivan to serve on the citizens' elections oversight

26 committee as a representative of the Municipal League for a three-year staggered term
27 ending July 2022 is hereby confirmed.
