1	AN ORDINANCE relating to extending the waiver for
2	public benefit rating system and timberlands application
3	fees; and amending Ordinance 1076, Section 4, as
4	amended, and K.C.C. 20.36.040.

7	STATEMENT OF FACTS:
8	1. Chapter 84.34 RCW authorizes counties to assess open space,
9	agricultural lands, and timberlands based on their current use rather than
10	their highest and best use in recognition of the public benefits that these
11	uses provide.
12	2. In 1992, the King County council approved Ordinance 1076
13	implementing the provisions of chapter 84.34 RCW and establishing
14	procedures, rules and fees for the consideration of applications for public
15	benefit rating system assessed valuation on "open space land" and for
16	current use assessment on "farm and agricultural land" and "timber land" as
17	those lands are defined in RCW 84.34.020.

18	3. In doing so, the King County council found that it is in the best interest
19	of the county to maintain, preserve, conserve and otherwise continue in
20	existence adequate open space lands for the production of food, fiber and
21	forest crops, and to assure the use and enjoyment of natural resources and
22	scenic beauty for the economic and social well-being of the county and its
23	citizens.
24	4. Since the establishment of King County's public benefit rating system,
25	more than six hundred landowners have enrolled, resulting in protection of
26	more than six thousand acres.
27	5. King County Comprehensive Plan policy E-101 directs that the county
28	should use incentives to protect and restore the natural environment
29	whenever practicable.
30	6. In order to facilitate applications to the public benefit rating system
31	program, the King County council approved Ordinance 15137 amending
32	K.C.C 20.36.040 to waive the application fee for the public benefit rating
33	system in 2005.
34	7. The King County council appropriated funding to the water and land
35	resources division in 2005 and 2006 to offset lost revenue for the fee waiver
36	and to increase the number staff dedicated to outreach and monitoring for
37	the public benefit rating system in 2005 and 2006.
38	8. With the implementation of the fee waiver and increase outreach to rural
· · · · · ·	land owners, applications to the public benefit rating system program

40	increased from fifty-six land owners in 2004, to eighty-four landowners in
41	2005.
42	8. The King County council would like to continue waive the application
43	fee as a mechanism for facilitating participation in the public benefit rating
44	system, and to extend the waiver to the timberlands program which provides
45	an incentive to small forest land owners to continue forest uses.
46	9. Funds were appropriated to the water and land resources division in 2006
47	to support continuation of the fee waiver. However, the authority to offer
48	the fee waiver expired at the end of 2005.
49	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
50	SECTION 1. Ordinance 1076, Section 4, as amended, and K.C.C. 20.36.040 are
51	each hereby amended to read as follows:
52	A. Except as provided in subsection C. of this section, the applicant shall pay a
53	current use filing fee as provided in K.C.C. 27.10.230, payable to the King County of
54	finance and business operations division, for each open space, farm and agricultural or
55	timber land application filed in calendar year 1973 or thereafter.
56	B. In the case of all farm and agricultural land applications, whether the application
57	is based on land within or outside of an incorporated area, the entire fee shall be collected
58	and retained by the county. In the case of open space or timber land applications based on
59	land in an incorporated area of the county, where the city legislative authority has set no
60	filing fee, the county fee shall govern and the entire fee shall be collected and retained by
61	the county. Where the city legislative authority has established a filing fee for open space
62	or timber land applications based on land in an incorporated area of the county, fees as set

Ordinance 15579 63 forth in K.C.C. Title 27 shall be collected by the county from the applicant and the county shall pay the city one-half of the fee collected; provided, that in no event shall the amount 64 65 paid to the city exceed the fee established by the city. 66 C.
