1	AN ORDINANCE waiving certain statutory and code
2	requirements relating to the citizen engagement process to
3	development countywide priorities; and declaring an
4	emergency.

7	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
8	SECTION 1. Findings:
9	A. The metropolitan King County council's adopted 2007 budget identified
10	priorities for people that are designed to earn public trust, to enhance the quality of life
11	and to protect public health and safety.
12	B. The metropolitan King County council included in the 2007 budget an
13	initiative to earn public trust that would engage county citizens through workshops and
14	other means in developing countywide priorities for their county government.
15	The report from this citizen engagement process will guide alignment of county
16	services to these priorities and will be adopted as a policy directive for development of
17	the executive's proposed 2008 budget.

18	C. The metropolitan King County council wishes to secure a contract with an
19	independent consultant to help in the conduct of this citizen engagement process by
20	conducting focus groups/workshops with randomly selected citizens. The work of the
21	focus groups/workshops will be used to provide guidance to the council on the citizens'
22	2008 budget priorities.
23	D. An emergency waiver of competitive bidding and formal solicitation
24	requirements of state and county law is necessary in order to expedite selection of the
25	consultant to assure that the results of the citizen engagement process are available in a
26	timely manner to inform the executive as he prepares his proposed budget for 2008, and
27	to provide citizen-based policy direction and budget priorities to the council during their
28	2008 budget deliberations.
29	E. It is the intent of the council to encourage participation of women and
30	minority-owned business enterprises in securing such a contract to honor the spirit of
31	K.C.C. chapter 4.18 to the fullest extent possible.
32	SECTION 2. The requirements for competitive bidding and formal solicitation of
33	services under chapters 36.32, 39.80 and 39.10 RCW and K.C.C. chapters 4.04, 4.16,
34	4.18, 12.16 and 12.18 are hereby waived with reference to any contracts relating to the
35	independent consultant to conduct this citizen involvement process. This waiver expires
36	upon completion of this project.
37	SECTION 3. For the reasons set forth in section 1 of this ordinance, the county

council finds as a fact and declares that an emergency exists due to the imminent

- timelines required for this citizen process, and that this ordinance is necessary for the
- immediate preservation of the peace, health, safety and welfare of the public.
