1	AN ORDINANCE making a supplemental appropriation
2	of \$875,000 to the public transportation construction-
3	unrestricted fund to provide additional appropriation
4	authority in support of the Northgate Transit Oriented
5	Development Park and Ride project; and amending the
6	2007 Budget Ordinance, Ordinance 15652, Section 119,
7	as amended, and Attachment B, as amended.

10	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
11	SECTION 1. Findings:
12	A. The plan to replace existing park and ride facilities that are presently provided
13	at the Northgate park and ride lot located at 11203 - 5th Avenue NE, Seattle, Washington
14	and to convey that lot to the city of Seattle requires the execution of leases for
15	replacement garage parking space with two project developers as well as a purchase and
16	sale agreement with the city of Seattle, together with an appropriation necessary to fund
17	the leases.

	B. The King County council has already authorized the lease with S	Simon				
Prope	rties and the sale of the park and ride facility. The proposed lease wit	h Northgate				
South	Commons LLC (Lorig Associates) provides three hundred fifty parki	ng stalls to				
replac	e stalls from the sale of the park and ride. The proposed lease extend	s for forty				
 years.	This appropriation ordinance amends the 2007 Budget Ordinance to	fund changes				
to the	terms of the lease. This capital budget increase is offset by reduction	s in operating				
costs over the forty-year term of the lease.
