1 AN ORDINANCE relating to the annexation of four
 2 parcels into Fire District 38, known as the Cedar Falls
 3 annexation, for the purpose of providing fire protection
 4 services.

6 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

7 SECTION 1. Findings:

8 A. A notice of intention proposing the annexation of four parcels into Fire
 9 District 38 for the purpose of providing fire protection services was filed with the county
 10 council on September 17, 2007.

11 B. Fire District 38 has approved the annexation in Resolution No. 209, passed on
 12 November 6, 2007.

13 C. The county council held a public hearing and has considered whether any
 14 obligation exists that the territory to be annexed to Fire District 38 must be required to
 15 assume pursuant to RCW 52.04.011.

16 D. The council has determined that Fire District 38 has no preexisting financial
 17 obligations or indebtedness which the property owners of the proposed annexation areas

18 would be obligated to assume.

19 SECTION 2. Incorporation of the territory described in Attachment A to this
20 ordinance into Fire District 38 is hereby approved.



Attachment A

Parcel A

That portion of the northeast quarter of Section 22, Township 23 North, Range 8 East, Willamette Meridian lying south of the north bank of the South Fork of the Snoqualmie River and;

the southeast quarter of Section 22, Township 23 North, Range 8 East, Willamette Meridian.

Parcel B

The southeast quarter of the northeast quarter and the northeast quarter of the southeast quarter of Section 27, Township 23 North, Range 8 East Willamette Meridian, in King County Washington, and;

that portion of the northeast quarter of the northeast quarter of Section 27, Township 23 North, Range 8 East, Willamette Meridian, in King County Washington, lying southeasterly of the southeasterly margin of Cedar Falls Road, as conveyed to the city of Seattle by deed under recording number 733102.

Parcel C

That portion of the southeast quarter of the southeast quarter of Section 27, Township 23 North, Range 8 East, Willamette Meridian, lying southeasterly of the centerline of Cedar Falls Road.

Parcel D

The east half of the northeast quarter of the northeast quarter of the northwest quarter, together with the northeast quarter of the southeast quarter of the northeast quarter of the northwest quarter, all in Section 35, Township 23 North, Range 8 East, Willamette Meridian, in King County Washington.
