110            ER2 EXPENDITURE RESTRICTION:

111 Of this appropriation, \$400,000 shall be expended or encumbered solely to  
112 contract with a King County nonprofit organization that pays bail for indigent individuals  
113 who would otherwise spend their pretrial time in jail, unnecessarily burdening the county  
114 with additional costs to incarcerate those individuals.

115 ER3 EXPENDITURE RESTRICTION:

116 Of this appropriation, \$75,000 shall be expended or encumbered solely to support  
117 the King County Sexual Assault Resource Center for a technology project.

118 ER4 EXPENDITURE RESTRICTION:

119 Of this appropriation, \$150,000 shall be expended or encumbered solely to  
120 support The Lighthouse for the Blind, Inc., for program expansion that would serve King  
121 County residents with visual impairment."

122 Renumber the remaining sections consecutively and correct any internal references  
123 accordingly.
