1 AMENDMENT TO STRIKING AMENDMENT S1 TO PROPOSED ORDINANCE

2 2020-0117, VERSION 1

3 On page 4, beginning on line 80, strike everything through line 86 and insert:

4 "SECTION 8. Ordinance 18835, Section 49, as amended, is hereby amended as
5 follows:

6 GENERAL FUND TRANSFER TO DEPARTMENT OF EXECUTIVE

7 SERVICES CAPITAL IMPROVEMENT PROGRAM - From the general fund there is

8 hereby disappropriated from:

9 General fund transfer to department of executive services capital improvement

10 program (\$17,833,000)

11 SECTION 9. The council directs that section 8 of this ordinance takes effect

12 before section 10 of this ordinance.

13 SECTION 10. Ordinance 18835, Section 49, as amended, is hereby amended as

14 follows:

15 GENERAL FUND TRANSFER TO DEPARTMENT OF EXECUTIVE

16 SERVICES CAPITAL IMPROVEMENT PROGRAM - From the general fund there is

17 hereby appropriated to:

18 General fund transfer to department of executive services capital improvement

19 program \$32,848,000

20 P1 PROVIDED THAT:

21 Of this appropriation, no moneys shall be expended or encumbered until the
22 executive transmits a plan related to the isolation, quarantine and recovery sites used by
23 the county in response to the coronavirus disease 2019, known as COVID-19, and a
24 motion that should acknowledge receipt of the plan and a motion that acknowledges
25 receipt of the plan is passed by the council. The motion should reference the subject
26 matter, the proviso's ordinance, ordinance section and proviso number in both the title
27 and body of the motion.

28 The plan shall include, but not be limited to:

29 A. Plans for security surrounding the isolation, quarantine and recovery sites;

30 B. Communication plans with the communities surrounding the isolation,

31 quarantine and recovery sites; and

32 C. Services to the residents that will be served by the isolation, quarantine and

33 recovery sites including, but not limited to, transportation to and from their last location

34 or home.

35 The executive shall transmit the plan and motion required by this proviso within
36 seven days after the first person occupies any of the isolation, quarantine and recovery
37 sites. The executive shall transmit the plan and motion in the form of an electronic copy
38 with the clerk of the council, who shall provide an electronic copy to all councilmembers,
39 the council chief of staff and the chief policy officer."

40 Renumber the remaining sections consecutively and correct any internal references

41 accordingly.

43 *EFFECT: This amendment would restrict the use of General Fund moneys for*
44 *Department of Executive Services (including FMD) capital projects until the executive*
45 *transmits to council a plan related to the isolation, quarantine and recovery sites used*
46 *by the county in response to COVID-19. The plan would be required to be transmitted*
47 *within seven days after the first person occupies any of the isolation, quarantine and*
48 *recovery sites. The plan shall include, but not be limited to:*

49 *A. Plans for security surrounding the quarantine and recovery sites;*

50 *B. Communication plans with the communities surrounding the quarantine*
51 *and recovery sites; and*

52 *C. Services to the residents that will be served by the quarantine and recovery*
53 *sites including, but not limited to transportation to and from their last location or*
54 *home.*
