WHEREAS, King County provides transit services to its residents to increase 5 6 mobility options and reduce traffic congestion and related environmental degradation, 7 and WHEREAS, the provision of passenger vans to nonprofit organizations and local 8 governments serving individuals with limited resources and mobility options will support 9 10 those goals and provide significant public benefits, and WHEREAS, high-quality passenger vans retaining value and utility are 11 periodically retired from the county's vanpool program, and 12 WHEREAS, the metropolitan King County council has previously transferred 13 retired vans to agencies serving low-income, elderly, disabled and young people, and 14 15 WHEREAS, K.C.C. 4.56.100 states that "each year the transit division shall make available retired passenger vans for exclusive use by nonprofit organizations or local 16 governments that are able to address the mobility needs of low-income, elderly or young 17 people or people with disabilities"; 18 NOW, THEREFORE, BE IT MOVED by the Council of King County: 19
