A RESOLUTION recognizing June 4 as Regional 1 2 Community Safety and Wellbeing Day in King County, as 3 part of national Gun Violence Awareness Day. 4 WHEREAS, on September 21, 2017, the King County Board of Health adopted Resolution 17-09 calling on lawmakers to take meaningful action to address firearm 5 6 tragedy, and 7 WHEREAS, on June 18, 2020, the King County Board of Health adopted Resolution 20-08 declaring racism a public health crisis and committing to work to 8 9 advance a public-health approach in addressing institutional and systemic racism, and 10 WHEREAS, Resolution 20-08 committed to being responsive to communities and residents impacted by racism, especially Black and Indigenous communities, and 11 WHEREAS, like COVID-19, youth and young adult gun violence is a fatal 12 epidemic, and 13 WHEREAS, gun violence in our neighborhoods, cities and county impacts public 14 15 health and public safety and deserves to be addressed through a robust public-health approach that enlists multisector supports, broad investments and lasting commitment; 16 and 17 18 WHEREAS, according to the 2019 Public Health Report on Gun Violence Among Youth and Young Adults, firearms are the leading cause of suicide and homicide 19

20	deaths among youth and young adults in King County, and
21	WHEREAS, through the end of September 2020, King County had already seen
22	more homicides than in all 12 months of 2019; and
23	WHEREAS, according to King County Prosecuting Attorney's Office data, 74
24	percent of the 256 shooting victims in the first three quarters of 2020 were people of
25	color and 46 percent were under 25, and
26	WHEREAS, Public Health - Seattle & King County ("PHSKC") is working to
27	develop and implement local strategies to reduce firearm-related homicide and violence,
28	and ensure all young people are healthy, hopeful, safe and thriving, and
29	WHEREAS, PHSKC's Zero Youth Detention team ("ZYD") is implementing that
30	work by taking a regional approach to community safety and wellbeing, aligning services
31	and coordinating efforts to support and provide resources for communities impacted most
32	by violence and racial disparities in King County, and
33	WHEREAS, in collaboration with over twenty city and county departments and
34	partners, ZYD is working to develop and implement a cocreated Community Safety and
35	Well-Being Plan, and
36	WHEREAS, in addition to long-term needs, ZYD is addressing the immediate
37	need for a responsive "Go First" strategy to address the current increased gun violence,

39	WHEREAS, community organizations are leading this work to provide violence
40	interruption through intervention, prevention and restoration under the name King
41	County Peace Keepers Collective, which includes Community Passageways, Black
42	Women's Coalition, Choose 180, Freedom Project, Alive & Free, Renegades for Life and

43	Progress Pushers, and	
44	WHEREAS, June 4 is National Gun Violence Awareness Day, and here in King	
45	County, ZYD and community partners are using that day to launch their "go first"	
46	strategy, a rigorous intervention for those directly involved in gun violence, secondary	
47	prevention for younger siblings and follow-up care and support for family restoration and	
48	healing;

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO King County ITD (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. # **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after signing session and, if you elect to create a DocuSign signer account, you may access them for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

# Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

# Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of a DocuSign envelope instead of signing it. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.
