NOTICE IS HEREBY GIVEN that the Metropolitan King County Council (the Council) held a public hearing remotely to comply with the Washington State Governor's Declaration 20-28 (or as amended) regarding the Open Public Meetings Act on Tuesday, November 17, 2020, beginning at 1:00 PM. The purpose of this public hearing was to consider adoption of Proposed Ordinance 2020-0310 (Ordinance 19195), adopting permitting fees.

SUMMARY

Ordinance 19195 updates King County Title 20 pertaining to permitting collection procedures and modifies permitting fees currently collected for permitting and environmental review services provided by the department of local services, permitting division and road services division, and the department of natural resources and parks to support the 2021-2022 King County Biennial Budget.
