11          King County, and

12          WHEREAS, RCW 29A.32.280 provides for each measure from a jurisdiction that  
13          is included in a local voters' pamphlet, the legislative authority of that jurisdiction shall  
14          formally appoint a committee to prepare arguments advocating voter approval of the  
15          measure and a committee to prepare arguments advocating voter rejection of the measure,

17          WHEREAS, Ordinance 19300, adopted June 15, 2021, provides for submission to  
18          the voters at a special election to be held in conjunction with the November 2, 2021,  
19          general election, an amendment to the Preamble to the King County Charter to include
