Ms. Patterson reported on the Sound Transit Capital Committee. The committee unanimously adopted a motion to authorize a contract for the design services for the south link, the portion from the airport to south 200th street. This contract will help Sound Transit produce technical information and updated cost estimates to better inform the Board about the delivery of light rail services to south 200th.

Ms. Drago commented that the Board had an overview of the budget and issues that are facing Sound Transit. She indicated that CEO Director, Joni Earl, will present her proposed budget to the Sound Transit board on September 23. There was also a motion to the Sound Transit Board, which would authorize the CEO to enter into a contract for final design and engineering for the UW/Northgate link.

Ms. Patterson briefed the Council on the Forecast Council. The Council received a briefing on the revised 2011 economic forecast for King County. Ms. Patterson indicated that King County's recovery is expected to happen at a much lower rate. The unemployment rate may increase before getting better and the inflation rate is expected to be lower for next year.

Ms. Hague reported on the Eastside Transportation Partnership. The members had a presentation on SR520 tolling that will begin in 2011, as well as a presentation on the I-405 corridor anticipated high occupancy transit lanes.
