17. <u>Reports on Special and Outside Committees</u>

Mr. Phillips reported on the recent meeting of the Sound Transit Board. The Board approved the acceleration of the south link light rail from SeaTac to South 200th. It will open at the same time as the University link to the University of Washington. The Board also selected an alignment for the east link light rail, connecting downtown Seattle to downtown Bellevue, and on to Redmond. The link will also provide a tunnel to downtown Bellevue.

Mr. McDermott briefed the Council on the Sound Transit Capital Committee. The members received a briefing on the steps moving forward in the east link program and steps within the design.

Mr. McDermott reported on the recent Board of Health meeting. Dr. Fleming, Director of Public Health delivered good news. The Department received a grant of over \$1 million from the federal Department of Health and Human Services to support school based health centers. He indicated that representatives from the Healthcare for the Homeless Network briefed the Board on their 2010 annual report.

Other Business

Mr. von Reichbauer requested a point of personal privilege to inform the members and to congratulate former Council staff member, Bailey Stenson, on the publishing of her book "Who We Are is Why We Win". He also congratulated her for her accomplishment with University of Washington team members for winning the 2009 national softball competition. He invited Bailey to the podium to answer questions.
