19. Reports on Special and Outside Committees

Ms. Hague reported on the Eastside Transportation Partnership. The members heard a presentation from the Washington State Department of Transportation regarding capital transportation projects and also King County's Department of Transportation regarding capital needs throughout King County.

Ms. Patterson reported on the Sound Transit Capital Committee. The committee heard a motion regarding Sound Transit's operating and maintenance satellite facilities, as Sound Transit's ST2 plan anticipates a larger number of vehicles than the current maintenance facility can hold, and a second facility is needed within the link light rail service area. She indicated that potential sites have been identified, however the motion was delayed until the next meeting. The committee also heard a briefing on the Seattle Fire Department's tunnel rescue team. Ms. Patterson stated that action was taken on a number of items, including a motion authorizing execution of an agreement with the City of Seattle to complete the Ballard to downtown Seattle high capacity transit planning study, which will be completed in the spring of 2014.
