The Board heard a briefing from Sound Transit and BNSF officials regarding the mudslides affecting the north Sounder train, indicating Sound Transit and BNSF are detailing a plan to help alleviate the impacts for commuter passengers. The Board unanimously supported a work plan for ST3.

Mr. Phillips briefed the Council on the Cedar River Council, indicating the major topic was a proposal by Puget Sound Energy to expand its natural gas delivery system in south King County. The Council also discussed membership opportunities for citizens to participate on the Cedar River Council.
