*Ms. Patterson reported on the Sound Transit Board. The board welcomed Lynn Peterson, Washington State Secretary of Transportation, as a new member. The board received an update on the University Link and East Link projects. University Link is 65% complete and is on schedule to begin operation in 2016. East Link is expected to begin operation in 2023. The board discussed four potential cost saving refinements to the project and will be voting on them at the next meeting. The board also appointed Michael Garrity to the Citizen Oversight Panel as a representative of Pierce County.*

*Mr. Phillips reported on the Cedar River Council. The council met with Jon Hansen, Environmental Scientist, King County, to discuss the Rainbow Bend project. The King County Flood Control District is helping to fund and implement the project as a high priority flood hazard management project.*

*Mr. Phillips also reported on the 4 Culture Board. The board heard a presentation on the lodging industry and the importance of spending tax dollars on marketing to promote tourism. The Board heard a report on Mukai Garden on Vashon Island. The garden is listed on the National Historic Register and has fallen into disrepair. 4 Culture has spent over \$100,000 to preserve the garden. Work is in progress to find a new governing structure to continue the work of repairing the garden and opening it to the public. Lastly, Mr. Phillips announced that there will be four open seats on the board on December 31, 2013.*

**Other Business**

*As a point of personal privilege, Mr. von Reichbauer discussed the recent We Day in Seattle. He introduced Associated Student Body President of Federal Way High School, Caleb Dawson, who briefed the council on the event. It was the first event of this kind in the nation and its goal is to empower youth to create positive change. 15,000 students were invited to attend the event. In order to attend, the student had to achieve one global and one local positive action in their community.*

*As another point of personal privilege, Mr. von Reichbauer announced that he, Councilmember Demobowski and Executive Constantine had dinner with the Counsel General of Korea. Mr. Dembowski also announced that he and Mr. von Reichbauer presented a special recognition to the Korean Counseling Community Services organization in honor of their 30 year anniversary.*

*As a point of personal privilege, Ms. Hague reported that she, Councilmember Phillips, Councilmember Dembowski and Executive Constantine attended the celebration of Eastside Rail Corridor's transfer of ownership into public hands.*
