The members heard a report on drafting Sound Transit's 2014 strategic objectives, which include the strategies and performance measures the agency will use, and also on Sound Transit's realignment of link light rail projects. She indicated that the Board nominated two applicants to represent South King County on the citizens oversight panel. The Board will take a vote at the next meeting. The Committee also discussed the possibility of developing a Sound Transit policy on equity and social justice.

Mr. Phillips reported on Mountains to Sound Greenway. The members elected a new board and also new members for the Board of Advisors. The Board reviewed its fiscal performance for the coming year.

Ms. Lambert reported on her attendance at the Washington State Association of Counties Conference in Yakima. She indicated the State Auditor's Office has a new department to help with the "Lean" program, and indicated it was one of the finest conferences she has attended. She learned about new ideas and is willing to share her notes with members at the next Council meeting.
