Councilmember Lambert reported on the Snoqualmie River Hydraulic Study Town Hall. Two projects addressing flooding on the Snoqualmie River by the Army Corps of Engineers and Puget Sound Energy resulted in improvements upstream. An independent study, funded by the King County Flood Control District, revealed a difference in annual flood events. Monitoring will continue regarding the impacts of flooding as well as the benefits and drawbacks following construction projects.

Councilmember Kohl-Welles attended the Growth Management Planning Council. Councilmember Kohl-Welles reported that the Growth Management Planning Council held a panel discussion on growth in the region. She indicated that population and job growth were discussed.

Councilmember Kohl-Welles reported on the King County Strategic Advisory Council annual meeting. Awards were presented as well as a recap of accomplishments in the 2014-2016 plan. Councilmembers discussed issues relating to reducing costs and creating revenue to fund the next plan, voted to endorse the Strategic Plan for the technology budget for 2016-2018 and provided feedback on the criteria for making IT investments in the next budget.

Councilmember Kohl-Welles attended the Puget Sound Regional Council. She reported that the 2016-2017 supplemental biennial budget and workplan were adopted and that elections were held for new officers.

Councilmember Kohl-Welles reported on the Seattle-North King County Transportation Forum. She reported that Patrice Hardy from Sound Transit provided an update on Sound Transit 3. There was also a discussion about the King County Metro Long Range Plan which will be coming out on April 5, 2016.
