Call to Order

The meeting was called to order at 1:37 p.m.

Roll Call

Mr. Phillips led the flag salute and Pledge of Allegiance.

1. Approval of Minutes of April 24, 2006

Mr. Gossett moved to approve the minutes of the April 24, 2006 meeting as presented. Seeing no objection, the Chair so ordered.

2. <u>Reports on Special and Outside Committees</u>

Ms. Patterson reported on the Puget Sound Regional Council Executive Board. She commented that the Board approves the updates of the policies that PSRC uses to distribute federal funds for roads, transit and trail projects. The projects go through an intense analysis and are prioritized.

Ms. Patterson reported on the Sound Transit Board. The Board approved a plan for extending link light rail from downtown Seattle to the University of Washington. The 3.1 mile extension connects downtown Seattle, Capitol Hill and the University District, and will add 70,000 riders a day. Construction will begin in 2008. Ms. Patterson indicated that the local African American community conducted a rally and protest and attended the meeting. They asked for greater participation by African American firms for contracting. Sound Transit made a pledge to continue to work with these groups.

Mr. Constantine reported on the Growth Management Planning Council. The Council discussed a potential annexation area map amendment allowing the City of Renton to include West Hill into the annexation area, and adding Overlake as an urban center to the City of Redmond. The Council also heard a presentation on Vision 2020.

Mr. Dunn reported on the Cedar River Council. The Council heard a briefing on the King County Mitigation Reserves Program and discussed the City of Seattle Muckleshoot Indian Tribe proposed agreement. A sub-committee is being formed under the Cedar River Council's direction to work with the tribe. *Ms.* Hague reported on the 4Culture Board meeting. The Board authorized \$150,000 for due diligence on the Maritime History Museum, made changes to is bylaws and had a discussion regarding lodging tax for arts and heritage.
