#### Call to Order

The meeting was called to order at 1:49 p.m.

#### **Roll Call**

### Flag Salute and Pledge of Allegiance

Mr. Dunn led the flag salute and Pledge of Allegiance.

### Approval of Minutes of September 11, 2006

Ms. Hague moved to approve the minutes of the September 11, 2006 meeting as presented. Seeing no objection, the Chair so ordered.

### 2. Special Items

#### Memorial of North Highline Resident Judy Duff for her Community Service

Mr. Constantine invited Judy Duff's family to join him at the podium. He spoke about Ms. Duff's service to the North Highline community. He read the memorial and presented it to Ms. Duff's daughter, Deanna. Deanna thanked the Council. Mr. Constantine invited those who were in attendance from the North Highline community to participate in a group photo.

# Presentation of a Recognition to Paul Wickenden, Exchange Visitor from the Kent County Council in England

The Chair invited Paul to join him at the podium while he read the Recognition. Paul made remarks. He gave personal thanks to the Chair and councilmembers, Anne Noris, Clif Curry and Carrie Cihak.

### 3. Reports on Special and Outside Committees

Ms. Patterson reported on the Sound Transit Board. The Board adopted routine amendments to the agency budget and is moving forward with the Sounder Everett Station project. The Board held the first of five public open houses throughout the region, sponsored by Sound Transit and RTID. She indicated the purpose of these open houses is to provide an opportunity for the public to learn more about the road and transit projects being considered for the 2007 ballot measure. A final comprehensive road and transit ballot proposal will be ready next spring to present to the voters. The next meeting is scheduled for September 20.

Mr. Constantine reported on the Growth Management Policy Board. The Board discussed the continuing challenge of improving the balance of jobs and housing in the region. The Board focused on the extent of a regional plan for balancing jobs and housing throughout the region. The Board

continues to meet monthly.

Ms. Patterson reported on the Puget Sound Regional Council Transportation Policy Board. The Board received an update on the progress being made regarding the preferred alternative for replacing the SR520 bridge. The Board is working with the State Department of Transportation to replace the bridge. The Board had a briefing on traffic management practices that are being used in Europe.

Ms. Patterson reported on the Board of Health and the status of the operational master plan which is currently being reviewed by stakeholders. She indicated that one hundred responses were received and that staff will make those changes. Ms. Patterson also indicated that the Board received a briefing on HPV (Human Papilloma Virus) and a new vaccine that has been developed for the virus. The Board of Health will continue to be updated over the course of the year.

Mr. Phillips reported on the Watershed Resource Inventory Area 8 Steering Committee. The WRIA 8 consists of King, Pierce and Snohomish Counties. The Committee considered the salmon recovery funding board's projects. Three projects were recommended and will move forward within the Lake Washington System.
