1. Approval of Minutes of September 18, 2006

Mr. von Reichbauer moved to approve the minutes of the September 18, 2006 meeting as presented. Seeing no objection, the Chair so ordered.

2. Special Items

Presentation of a Recognition of Stafford L. Smith, retiring Hearing Examiner for the King County Council, for outstanding service

Mr. Phillips invited Mr. Smith to the podium while he read the Recognition. Mr. Smith spoke and thanked the Council.

Presentation of a Proclamation of September 2006 as Emergency Preparedness Month

Ms. Lambert made remarks about the importance of emergency preparedness. The following individuals joined her at the podium while she read the Proclamation and also made remarks: Gene Laughlin, Coordinator, Community Emergency Response Team/Duvall, Jeffrey Guite, President, American Preparedness, John Murphy, Deputy Chief, Eastside Fire & Rescue and Eric Holdeman, Director, Office of Emergency Management.

3. Reports on Special and Outside Committees

Ms. Patterson reported on the South County Area Transportation Board, a consortium of representatives of all of the south King County cities who come together to make decisions on how to invest public funds in transportation. The Board received an update on the ballot proposal Transit Now, and discussed RTID and Sound Transit's progress in refining the roads and transit ballot plan for 2007. On September 27, Sound Transit and RTID will jointly host a public open house at the King County Aquatic Center in Federal Way, which will give the public an opportunity to voice their opinion on road and transit priorities.

Ms. Patterson briefed the Council on the recent meeting of the RTID Executive Board. The Board received an update from the Washington State Department of Transportation on the increased cost estimates for the necessary repair for the SR520 bridge, and the Alaska Way viaduct. RTID and Sound Transit are continuing to work together to develop a road and transit plan to present to the voters for approval in 2007. Ms. Patterson noted that the report issued by the State's Expert Review Panel indicated it was a shared responsibility between the state, region and local governments to complete these major road projects. The goal is to have all work completed before the beginning of the legislative session.

4. Plat Tracings

Mr. Constantine moved to adopt the DDES finding of fact that the final plats of Pine Classics and Cho Subdivision comply with the conditions of preliminary plat approval and other applicable laws, and that the Chair is authorized to signify Council approval by signing the final plats at the end of the meeting.
