*Ms.* Patterson reported on the Puget Sound Regional Council Transportation Policy Board meeting. The Board released, for public comment, a contingency list of transportation projects for use in case there is additional American Reinvestment and Recovery Act funds. The Board also received updates from the Transportation 2040 working group, the pricing task force and the Transportation 2040 outreach effort.

Ms. Patterson reported on the recent Sound Transit meeting and the extensive public involvement

process on the east link light rail route. The Board identified a preferred route for extending light rail from downtown Seattle to Mercer Island and Bellevue, and eventually to Redmond. The Board also adopted a rail fare enforcement policy for commuter and light rail lines.

Ms. Patterson briefed the Council on the Joint Subarea Transportation Board, which includes SCAT Board (South County Area Transportation Board), SEASHORE (Seattle and Shoreline) and ETP (Eastside Transportation Partnership). This Board represents the three geographic areas in King County, and met regarding the funding shortfall with Metro Transit. She indicated that Kevin Desmond, General Manager, Metro Transit, explained the funding situation. The Board also heard a report from executive staff on highlights of the significant transportation legislation and the state transportation budget of the 2009 session.
