1. Approval of Minutes

The minutes of the June 1, 2005 meeting were held.

2. Chair's Report

Chair Ferguson introduced Kathleen Southwick, Executive Director, Crisis Clinic. Ms. Southwick briefed the committee from a document entitled, "Status Report on 2-1-1", noting that the system is expected to be launched in 2006.

A press release from King County Executive Ron Sims regarding the formation of the "Healthy Families and Communities Task Force" which will be co-chaired by Metropolitan King County Council Budget Chair Larry Gossett and Renton Mayor Kathy Keolker-Wheeler, was distributed to the members.

Chair Ferguson noted that the legislation on the Veteran's ballot measure will be distributed for review prior to introduction to the King County Council at the end of the month.

The amendment passed unanimously.
